15 the state superintendent of education and the secretary of the Louisiana Department of
16 Health, who shall seek input on the appointments from offices and organizations that serve
17 the deaf community, including but not limited to the Louisiana Early Hearing Detection and
18 Intervention Program, the Early Steps Program, and the Louisiana Commission for the Deaf.
19 When making these appointments, preference shall be given, if applicable, to persons with
20 deaf education certification or with early childhood education certification and experience
21 working with children with hearing loss."
