1 A RESOLUTION

2 To commend the Honorable Michael E. "Mike" Danahay and to express enduring gratitude  
3 for his outstanding contributions to Beauregard and Calcasieu Parishes and the state  
4 of Louisiana, particularly during his tenure as a distinguished member of the  
5 Louisiana House of Representatives.

6 WHEREAS, Michael Danahay is a notable public servant who has served with  
7 excellence as a state representative since taking office in 2008, during which time he has  
8 fully used every opportunity to serve the citizens of his district and the state in an honorable  
9 and dedicated manner; and

10 WHEREAS, Representative Danahay earned a bachelor of science in business  
11 administration from McNeese State University; and

12 WHEREAS, Representative Danahay has been a proud member of the Louisiana  
13 Legislative Democratic Caucus, Rural Caucus, and Acadiana Delegation; and

14 WHEREAS, Representative Dahanay's diligent committee service has included  
15 serving as chairman and vice-chairman of the House Committee on House and  
16 Governmental Affairs, and serving as a member of the Legislative Budgetary Control  
17 Council, the Joint Legislative Committee on Capital Outlay, the House Executive

2 Danahay has supported many important pieces of legislation; he exemplified the highest

4 Southwest Louisiana Economic Development Alliance with the Governmental Affairs  
5 Award for his diligent work for the people of Southwest Louisiana; and

6           WHEREAS, in 2009, the Louisiana Civil Service League awarded Representative  
7 Danahay with the Monte M. Lemann Award for promoting the study of the state civil service  
8 system; and

9           WHEREAS, Mike Danahay will forever have a special place in the chronicles of the  
10 history of Louisiana, for he is one of Louisiana's most outstanding public servants - a man  
11 of integrity, dedication, and fairness and a master of the political process; and

12           WHEREAS, as he prepares to embark on the next exciting and productive chapter  
13 of his life, Representative Danahay merits a sincere measure of commendation for his  
14 singular contributions and the exemplary strides he has taken as a member of the Louisiana  
15 House of Representatives.

16           THEREFORE, BE IT RESOLVED that the House of Representatives of the  
17 Legislature of Louisiana does hereby commend the Honorable Michael E. Danahay; does  
18 hereby extend honor and recognition to him for his outstanding accomplishments; and does
