2 On page 2, delete lines 3 through 16 in their entirety and insert in lieu thereof the following:

3 "(a) The medical necessity of the services is documented for a Medicaid  
4 recipient receiving more than twelve hours of CPST and PSR services per day per  
5 rendering provider.

6 (b) The services are billed for a group setting. However, the total hours  
7 worked by an individual rendering provider shall not exceed twelve reimbursable  
8 hours per calendar day.

9 (c) The services are billed for crisis intervention."

22 (4) The provisions of this Subsection shall not apply to evidence-based  
23 practices including, without limitation, the practices known as assertive community  
24 treatment, multisystemic therapy, functional family therapy, and homebuilders."
