HOUSE BILL NO. 15

1 AN ACT

2 To amend and reenact R.S. 11:1733(F), 1753(C), and 1923(C), relative to the Municipal  
3 Employees' Retirement System of Louisiana and the Parochial Employees'  
4 Retirement System of Louisiana; to provide with respect to membership of certain  
5 employees in Lafayette; and to provide for related matters.

6 Notice of intention to introduce this Act has been published  
7 as provided by Article III, Section 13 and Article X, Section  
8 29(C) of the Constitution of Louisiana.

9 Be it enacted by the Legislature of Louisiana:

10 Section 1. R.S. 11:1733(F), 1753(C), and 1923(C) are hereby amended and  
11 reenacted to read as follows:

12 §1733. Agreement for coverage of employees of incorporated cities, towns, villages  
13 and tax boards or commissions

14 \* \* \*

15 F.(1)(a) Notwithstanding any other provision of law, if an employer  
16 terminates its agreement for coverage of its employees, the employer shall remit that  
17 portion of the unfunded accrued liability existing on June thirtieth immediately prior  
18 to the date of termination which is attributable to the employer's participation in the  
19 system.

20 (b) Notwithstanding any other provision of law, if an employer eliminates  
21 an employee position or class of positions covered by this system by contracting with  
22 a private entity for the work formerly done by employees in eliminated positions, the

1 employer shall remit that portion of the unfunded accrued liability existing on June  
 2 thirtieth immediately prior to the date of privatization which is attributable to the  
 3 eliminated position or class of positions.

4 (c)(i) Except as provided in Item (ii) of this Subparagraph and  
 5 notwithstanding any other provision of law to the contrary, if an employer eliminates  
 6 any position from system coverage, the employer shall remit that portion of the  
 7 unfunded accrued liability existing on the June thirtieth immediately prior to the date  
 8 of elimination which is attributable to the eliminated position.

9 (ii) If a position is eliminated from system coverage because the person  
 10 occupying the position is laid off or if a vacant position is eliminated from system  
 11 coverage, no payments pursuant to Item (i) shall be due; provided, however, that if  
 12 any new position is established or an eliminated position is reestablished and the  
 13 person employed to fill that position does not become a member of this system, the  
 14 payments required by Item (i) of this Subparagraph shall be calculated and remitted  
 15 as though the position had been eliminated from system coverage.

16 (2) When an employer terminates its agreement for coverage of its  
 17 employees or eliminates a position or class of positions from system coverage for  
 18 any reason, this system shall notify each other Louisiana state and statewide  
 19 retirement system. If that employer enrolls an employee or class of employees in a  
 20 system that received notice of termination or elimination from this system, that other  
 21 system shall notify this system of the enrollment within fifteen days.

22 ~~(2)~~ (3) The amount due shall be determined by the actuary employed by the  
 23 system using the entry age normal funding method and shall either be paid in a lump  
 24 sum or amortized over ten years in equal monthly payments with interest at the  
 25 system's actuarial valuation rate in the same manner as regular payroll payments to  
 26 the system, at the option of the employer.

27 ~~(3)~~ (4) Should the employer fail to make a payment timely, the amount due  
 28 shall be collected in the same manner as authorized by Subsection E of this Section  
 29 and R.S. 11:1864.
