A JOINT RESOLUTION

Proposing to amend Article VIII, Section 6(A) of the Constitution of  
Louisiana, relative to state college and university boards; to rename the  
Board of Trustees for State Colleges and Universities; and to specify  
an election for submission of the proposition to electors and provide a  
ballot proposition.

Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of  
the members elected to each house concurring, that there shall be submitted  
to the electors of the state, for their approval or rejection in the manner  
provided by law, a proposal to amend Article VIII, Section 6(A) of the  
Constitution of Louisiana, to read as follows:

§6. Board of ~~Trustees~~ **Supervisors** for State Colleges and Universities  
Section 6.(A) Creation; Functions. The Board of ~~Trustees~~  
**Supervisors** for State Colleges and Universities is created as a body  
corporate. Subject to powers vested by this Article in the Board of  
Regents, it shall have supervision and management of state colleges and

1 universities not managed by a higher education board created by or  
2 under this Article.

4 Section 2. Be it further resolved that this proposed amendment shall be  
5 submitted to the electors of the state of Louisiana at the statewide election  
6 scheduled to be held on the Tuesday next after the first Monday in November,  
7 1998.

8 Section 3. Be it further resolved that on the official ballot to be used  
9 at the election there shall be printed a proposition, upon which the electors of  
10 the state shall be permitted to vote FOR or AGAINST, to amend the  
11 Constitution of Louisiana, which proposition shall read as follows:

12 To rename the Board of Trustees for State Colleges and  
13 Universities the Board of Supervisors for State Colleges and  
14 Universities. (Amends Article VIII, Section 6(A))

Dardenne (SB 42) DIGEST

Proposed constitutional amendment renames the management board for state colleges and universities from the Board of Trustees for State Colleges and Universities to the Board of Supervisors for State Colleges and Universities. Specifies submission of the amendment to the voters at the statewide election scheduled to be held on Tuesday next after the first Monday in November, 1998.
