EXPENDITURES:

The proposed legislation would allow 40 Crescent City Connection Police Officers, 62 Orleans Levee District Police Officers, and 75 Port of New Orleans Harbor Police Officers to receive \$300/month in state supplemental pay. The total cost of adding these 177 officers would be \$637,200 per year.

REVENUES:
