EXPLANATION OF ESTIMATES:

EXPENDITURES:

This bill will increase local expenditures. The start-up costs for the Zachary community school system in fiscal year 2000-01 is estimated at \$1,500,000. Major start-up costs would include administrative costs such as planning and the hiring of a superintendent, business officers, and other administrative personnel. We assumed that the school system would not be established until fiscal year 2000-01 and that the current capital equipment and facilities will transfer to the Zachary community school system. If capital equipment and facilities are not transferred to the Zachary Community school system, expenditures could increase by an interminable amount due to the need to lease and/or purchase these assets.

Additional local expenditures for general administration costs and an emergency fund for the Zachary community school system are estimated to be \$942,000 annually. This estimate is based on the assumption that current expenditures for instruction, student support, school administration, operations/maintenance, etc. in the Zachary schools do not constitute a new expenditure and will not change. If these current expenditures change, the anticipated increase in expenditures may be more or less than \$942,000. (continued on page 2)

REVENUES:

There is no anticipated direct effect on revenues as a result of this measure. We assumed that the local sales and property taxes currently allocated to the EBR Parish School District for the Zachary schools will be reallocated to the Zachary community school system. Any taxes levied in the future by the Zachary community school system would increase local revenues. However, at this time the likelihood and amount of such additional revenues are unknown. Also, state and federal funds currently allocated to the EBR Parish School District for the Zachary students will be reallocated to the Zachary community school district.
