BY REPRESENTATIVES MONTOUCET, FRANKLIN, HILL, HODGES, HONORE,
HOWARD, TERRY LANDRY, LEBAS, LEOPOLD, MACK, ORTEGO, PYLANT,
RICHARD, AND ST. GERMAIN AND SENATOR BROWN

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

HIGHWAYS: Designates portions of certain highways

1 AN ACT

2 To designate a portion of Louisiana Highway 91 in Acadia Parish as the "Corporal Matthew
3 Thomas Richard Memorial Highway"; to designate a portion of Louisiana Highway
4 347 in St. Martin Parish as the "Albert "Pyook" Berard Highway"; and to provide for
5 related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. The portion of Louisiana Highway 91, known as Iota Highway in Acadia
8 Parish, between its intersection just east of the town of Egan with Louisiana Highway 91,
9 the "Egan Highway", and its intersection with Louisiana Highway 98 in Iota, shall be
10 hereinafter known and designated as the "Corporal Matthew Thomas Richard Memorial
11 Highway".

12 Section 2. The portion of Louisiana Highway 347 in St. Martin Parish, known as
13 "Cecilia Senior High South Highway", between its intersection with Louisiana Highway 686,
14 "Coteau Rodaire Highway", and its intersection with Louisiana Highway 328, "Anse
15 Broussard Highway", shall be hereinafter known and designated as the "Albert "Pyook"
16 Berard Highway".

17 Section 3. The Department of Transportation and Development and its contractors
18 are hereby directed to erect and maintain appropriate signage of this designation.

Designates a portion of La. Hwy. 91 in Acadia Parish as the "Corporal Matthew Thomas Richard Memorial Highway".

Designates a portion of La. Hwy. 347 in St. Martin Parish as the "Albert "Pyook" Berard Highway".

Directs the Dept. of Transportation and Development to erect and maintain appropriate signage reflecting these highway designations.
