18 including motor oil, kerosene, gasoline, gasohol, diesel fuel, aviation fuel, heating
19 kerosene, and any blend of two or more refined hydrocarbon mixtures except
20 liquefied petroleum gas and natural gas. However, for purposes of enforcement of
21 the provisions of R.S. 47:818.101 et seq., with respect to the taxes on special fuels,
22 the term "petroleum product" shall include compressed natural gas, liquefied natural
23 gas, and liquefied petroleum gas as those terms are defined in R.S. 47:818.2.

2 amount of the decal shall be calculated at a rate of one-twelfth of the total annual
3 decal amount for each month the decal is valid."
