Designates the intersection of LA Hwy 182 and LA Hwy 358 in Opelousas as the "St. Landry Parish Memorial Intersection" and designates the US 190 bridge in Krotz Springs as the "Sal and Frank Diesi Bridge". (8/1/15)

Proposed law designates the intersection of La Hwy 182 and La Hwy 358 in Opelousas as the "St. Landry Parish Memorial Intersection." Proposed law designates the US 190 bridge crossing the Atchafalaya River near Krotz Springs as the "Frank and Sal Diesi Bridge." Proposed law designates that portion of La Hwy 182 from the Harry Guilbeau Road in Opelousas, La., to the intersection of La Highway 182 and La Hwy 358 as the "St. Landry Parish Veterans Memorial Highway." Proposed law directs DOTD to erect and maintain signs of such designations, limited to two signs at each location.

**EXPENDITURE EXPLANATION**

Proposed law will create a direct and indirect increase in expenditures. DOTD will expend approximately \$2,850 of TTF-Regular for the material, fabrication cost, mounting posts and installation required for the installation of two signs designating the intersection of LA Hwy 182 and LA Hwy 358 in Opelousas, the placement of a sign on each directional lane of US 190 approaching the bridge crossing the Atchafalaya River near Krotz Springs, and the placement of a sign on each directional lane between the intersection of La Hwy 182 and Harry Guilbeau Road in Opelousas, La. and the intersection of La Hwy 182 and La Hwy 358 (estimated as Labor \$587, Equipment \$917, Materials \$1,346). DOTD installs and maintains signage as a normal operating expense associated with maintaining the state highways.

The indirect increase in expenditures is attributable the long-term maintenance and possible replacement costs for damaged or destroyed signs. The maintenance cost over time should be negligible, but to the extent that additional signage is added to the department's inventory each year, the department's efforts to maintain them increase incrementally.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
