Edmonds

Existing law provides that if a defendant successfully completes the Offender Rehabilitation and Workforce Development Program and all other requirements of the workforce development sentencing program, the defendant can petition the court to suspend the remainder of his sentence and be placed on probation under the intensive supervision of the reentry court.

New law retains existing law and further provides that a minimum mandatory sentence that is generally imposed without the option of probation, parole, or suspension of sentence may be suspended if the defendant is placed on probation under the supervision of the reentry court unless the crime before the court involves a firearm or dangerous weapon during the commission of a crime of violence pursuant to R.S. 14:95(E) (illegal carrying of weapons).
