1 AMENDMENT NO. 1

2 On page 1, delete line 2 in its entirety and insert the following:

4 through (60), (D)(5), (Schedule II)(B)(29), (F)(2), and"

6 On page 1, line 3, after "(Schedule V)(D)(4)" and before the comma "," insert "and (F)(1)"

8 On page 1, line 4, before "to add" insert "to amend the definition of marijuana;"

10 On page 1, delete lines 7 through 8, and insert the following:

11 "Section 1. R.S. 40:961(25) is hereby amended and reenacted and R.S.
12 40:964(Schedule I)(A)(57) through (60), (D)(5), (Schedule II)(B)(29), (F)(2), and (Schedule
13 V)(D)(4) and (F)(1) are hereby enacted to read as follows:

14 §961. Definitions

15 As used in this Part, the following terms shall have the meaning ascribed to
16 them in this Section unless the context clearly indicates otherwise:

18 (25) "Marijuana" means all parts of plants of the genus Cannabis, whether
19 growing or not; the seeds thereof; the resin extracted from any part of such plant; and
20 every compound, manufacture, salt, derivative, mixture, or preparation of such plant,
21 its seeds or resin, but shall not include the mature stalks of such plant, fiber produced
22 from such stalks, oil or cake made from the seeds of such plant, any other compound,
23 manufacture, salt, derivative, mixture, or preparation of such mature stalks (except
24 the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of such plant
25 which is incapable of germination, or cannabidiol when contained in a drug product
26 approved by the United States Food and Drug Administration.

5 AMENDMENT NO. 7

6 On page 3, after line 6, insert the following:

7 "F. Hallucinogens
8 (1) (2-[3-Methyl-6-(1-methylethenyl)-2-cyclohexen-1-yl]-5-pentyl-1,3-
9 benzenediol) cannabidiol when contained in a drug product approved by the United
10 States Food and Drug Administration."
