9 "Section 3. Prior to complete implementation of the provisions of  
10 this Act, particularly the exclusive enforcement responsibilities as provided  
11 in R.S. 40:1749.27(A)(1), the office of conservation of the Department of  
12 Natural Resources shall enter into a Memorandum of Understanding with the  
13 office of state police of the Department of Public Safety and Corrections to  
14 delineate shared responsibilities through a transition period until such time  
15 as the office of conservation has promulgated and finally adopted the rules  
16 required by R.S. 40:1749.27(A). At such time as the office of conservation  
17 has finally adopted the rules required by R.S. 40:1749.27(A), the provisions  
18 of this Act shall be completely implemented and the commissioner of  
19 conservation shall have exclusive authority to enforce the provisions of R.S.  
20 40:1749.27."
