Amendments proposed by Senate Committee on Revenue and Fiscal Affairs to Original Senate Bill No. 95 by Senator Morrish

1 AMENDMENT NO. 1

2 On page 1, line 4, change "(B)(1)(c)(iv), (vii)," to "(B)(1)(c)(vii),"

3 AMENDMENT NO. 2

4 On page 1, delete line 5, and insert:

5 "(2)(a)(i), (C)(1)(e), and (2) and to repeal R.S."

6 AMENDMENT NO. 3

7 On page 1, line 7, delete "to limit the" and delete lines 8 through 10, and insert "to provide
8 for an effective date; and to"

9 AMENDMENT NO. 4

10 On page 1, delete lines 15 and 16, and insert:

11 "6301(A)(2), 6301(A)(2)(c), and (3), (B)(1)(c)(vii) and (ix), (2)(a)(i),(C)(1)(e), and
12 (2) are hereby amended and reenacted to read as follows:"

13 AMENDMENT NO. 5

14 On page 2, line 3, change "July 1, 2017" to "January 1, 2018"

15 AMENDMENT NO. 6

16 On page 2, delete lines 13 through 16 and insert:

17 "income tax return. The amount of the ~~rebate~~ **credit** shall be equal to the actual
18 amount of the taxpayer's donation used by a school tuition organization to fund a
19 scholarship to a qualified student, which shall not include administrative costs."

20 AMENDMENT NO. 7

21 On page 3, delete lines 4 and 5, and insert:

22 "the school tuition organization on scholarships, which shall not include
23 administrative costs and shall be prorated as applicable."

2 On page 4, delete lines 21 through 23, and insert:

3 "a scholarship from that school tuition organization. The report shall"

4 AMENDMENT NO. 11

5 On page 4, line 29, after "**January**" insert "**, unless granted an extension of no more than**
6 **thirty days by the Department of Education for good cause,**"

7 AMENDMENT NO. 12

8 On page 5, delete lines 5 through 9, and insert "the first day of February of each year."

9 AMENDMENT NO. 13

10 On page 5, line 11, after "(2)(a)" delete the remainder of the line and insert:

11 "For purposes of this Section, a "qualified school" shall mean a nonpublic
12 elementary or secondary school in this state which is approved, provisionally
13 approved, or probationally approved by the Board of Elementary and Secondary
14 Education and which complies with the criteria set forth in *Brumfield, et al. v. Dodd,*
15 *et al., 425 F. Supp 528.* A qualified school shall do all of the following:"

25 aware of the availability of scholarships, with an emphasis on notifying parents of
26 students in public schools that received a letter grade of "F" or "D", and shall provide
27 for requirements for school tuition organizations to adequately ~~advertise the~~ **notify**
28 **the public of the** availability of scholarships ~~to the public,~~ all as provided for in
29 rules and regulations which shall be promulgated by the Department of Education
30 in accordance with the Administrative Procedure Act."
