4    and "in accordance with the regular testing schedule established by federal and state law,  
5    rules, and regulations, a"

6    AMENDMENT NO. 13

7    On page 3, line 14, after "standards" delete the remainder of the line and delete lines 15 and  
8    16 in their entirety and insert in lieu thereof the following:

9    "required pursuant to Subsection C of this Section and any other secondary drinking water  
10   standards established by the United States Environmental Protection Agency known to be  
11   present in the utility's public water supply in an excessive amount until such time as the  
12   contaminant level tests within the acceptable range."

15   system shall, within five calendar days of receiving the results for"

13 Subsection F of this Section, for the enforcement of the secondary drinking  
14 water standards required pursuant to Subsection C of this Section receives"

15 AMENDMENT NO. 27

16 On page 5, line 27, after "Section," change "that" to "the state"

17 AMENDMENT NO. 28

18 On page 6, line 3, after "guarantee" delete "that"

19 AMENDMENT NO. 29

20 On page 6, line 12, after "Commission" delete "shall" and insert in lieu thereof "or other  
21 appropriate state entity may"

22 AMENDMENT NO. 30

23 On page 6, line 14, after "consumer" change "that" to "which"

24 AMENDMENT NO. 31

25 On page 6, after line 16, add the following:

26 "Section 2. This Act shall become effective upon signature by the  
27 governor or, if not signed by the governor, upon expiration of the time for  
28 bills to become law without signature by the governor, as provided by Article  
29 III, Section 18 of the Constitution of Louisiana. If vetoed by the governor  
30 and subsequently approved by the legislature, this Act shall become effective  
31 on the day following such approval."
