Amendments proposed by Senate Committee on Education to Original Senate Bill No. 82

1 AMENDMENT NO. 1

2 On page 1, line 2, after "17:24.4(F)(1)(a)" delete "and (c)" and insert "and to enact R.S.
3 17:24.4(L)"

4 AMENDMENT NO. 2

5 On page 1, delete lines 5 and 6, and insert "require the governing authority of each public
6 high school to ensure that certain students are college ready; to require each school
7 governing authority to reimburse certain public postsecondary institutions for the cost of
8 remedial and developmental coursework; and to provide for related matters."

9 AMENDMENT NO. 3

10 On page 1, line 8, after "17:24.4(F)(1)(a)" delete the remainder of the line and insert "is
11 hereby amended and reenacted and R.S. 17:24.4(L) is hereby enacted to read"

12 AMENDMENT NO. 4

13 On page 2, delete lines 1 through 9, and insert the following:

14 **"L.(1) The governing authority of each public high school shall ensure**
15 **that each student who graduates from high school after completing a college**
16 **preparatory curriculum has the basic knowledge and skills needed to undertake**
17 **entry-level postsecondary coursework as demonstrated by the student meeting**
18 **the college readiness benchmarks established by ACT for English and**
19 **mathematics.**

20 **(2) For a student who fails to meet the established college readiness**
21 **benchmarks and who is required to take remedial or developmental coursework**
22 **as a condition of admission or enrollment at a Louisiana public postsecondary**
23 **education institution, the institution may seek and receive reimbursement from**
24 **the governing authority of the public high school from which the student**
25 **graduated for the cost of providing the required remedial or developmental**
26 **coursework.**

27 **(3) The amount of reimbursement shall not exceed the postsecondary**
28 **institution's published tuition amount for the remedial or developmental**
29 **coursework undertaken.**

30 **(4) Reimbursement shall not be provided for a student to take the same**
31 **level of coursework more than once, whether or not the student completes the**
32 **course.**

33 **(5) Reimbursement shall not be provided for a student to take more than**
34 **two remedial or developmental courses.**

35 **(6) A public postsecondary education institution shall not receive**
36 **payment from both a student and a public school governing authority for the**
37 **same remedial or developmental coursework.**

38 **(7) The provisions of this Subsection shall apply only if the student**
39 **enrolls in a public postsecondary education institution and is required to take**
40 **remedial or developmental coursework during the academic year immediately**
41 **following graduation from high school."**
