Amendments proposed by House Committee on Ways and Means to Reengrossed Senate Bill No. 254 by Senator Morrell

1 AMENDMENT NO. 1

2 On page 1, at the beginning of line 6, after "(4)," and before "(C)(4)(f)" delete "R.S.
3 47:6007(C)(4)(b) and" and insert "R.S. 47:6007"

4 AMENDMENT NO. 2

5 On page 2, line 10, after "and (4)," delete the remainder of the line in its entirety and insert
6 "R.S. 47:6007"

7 AMENDMENT NO. 3

8 On page 3, line 21, after "and" and before "for" insert a comma ", and insert "**except for**
9 **fringe benefits not includible in gross income,**"

10 AMENDMENT NO. 4

11 On page 4, line 11. after "Section." delete the remainder of the line and delete lines 12
12 through 15 in their entirety and at the beginning of line 16, delete "**thereunder.**"

13 AMENDMENT NO. 5

14 On page 5, line 13, after "marketing and distribution", insert "**except as otherwise provided**
15 **by Subparagraph (a) of this Paragraph,**"

16 AMENDMENT NO. 6

17 On page 6, line 19, after "employee." delete the remainder of the line in its entirety and
18 delete line 20 in its entirety and insert the following:

19 **"Procurement companies that meet the definition established by rule by the**
20 **office pursuant to the Administrative Procedure Act shall be considered a**
21 **source within the state for purposes of this Section. However, the rule shall not**
22 **exclude from the definition of a "procurement company", a company or vendor**
23 **which is actively engaged in the business of obtaining goods or services that is**
24 **organized and maintains its principal place of business in this state, maintains**
25 **commercially-zoned immovable property and operates an office in this state, is**
26 **a registered dealer for purposes of state sales and use tax collection and**
27 **remittance, files a state income tax return, and employs Louisiana residents."**
