HOUSE BILL NO. 150

1 AN ACT

2 To amend and reenact R.S. 25:231, 232(A), and 234(A), relative to the South St. Landry
3 Community Library District; to provide relative to the name of the district; and to
4 provide for related matters.

5 Notice of intention to introduce this Act has been published
6 as provided by Article III, Section 13 of the Constitution of
7 Louisiana.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. R.S. 25:231, 232(A), and 234(A) are hereby amended and reenacted to
10 read as follows:

11 §231. Armand J. Brinkhaus, Sr., South St. Landry Community Library District;
12 creation; boundaries

13 The Armand J. Brinkhaus, Sr., South St. Landry Community Library District
14 is hereby created within the boundaries of St. Landry Parish ~~Police Jury Election~~
15 ~~District Eight~~, including the municipalities of Sunset, Grand Coteau, and Cankton,
16 and having the following specific boundaries: Beginning on the Southwest Common
17 Border of St. Landry and Acadia Parishes at the junction of the parish boundary line
18 and Highway 754; thence east on Highway 754 and following said highway in its
19 eastern movement to the east section line of Section 25, T7S, R4E, and also a
20 junction with Bayou Bourbeau; thence following flow of bayou in its northerly and

1 northeastern directions to Ward 1, Ward 2 boundary line; thence east on said ward
 2 line and following said ward line in an easterly direction to junction with Bayou
 3 Bourbeau and thence following the Bayou Bourbeau and also the ward line to a point
 4 in the southeast corner of Section 144, T7S, R4E, at which point the ward line
 5 changes direction to south-southwest, following said line south-southwest to its
 6 termination at the southern boundary line of St. Landry Parish; thence following the
 7 common boundary of St. Landry and Lafayette Parishes in its southwesterly direction
 8 to its southwestern extremity; thence on its northerly direction on said common
 9 boundary of St. Landry and Acadia Parishes to the junction of Highway 754 and the
 10 point of beginning.

11 §232. Board of commissioners; appointment; terms; qualifications; removal of
 12 members

13 A. There is created a board of commissioners of the Armand J. Brinkhaus,
 14 Sr., South St. Landry Community Library District, domiciled in the parish seat, to
 15 be composed of seven members. The mayor of the municipality of Sunset shall
 16 appoint one member who shall serve for one year. The mayor of the municipality
 17 of Grand Coteau shall appoint one member who shall serve for one year. The mayor
 18 of the municipality of Cankton shall appoint one member who shall serve for one
 19 year. The governing authority of St. Landry Parish ~~Police Jury~~ shall appoint one
 20 member to serve for one year, one for two years, one for three years, and one for five
 21 years. Their successors shall each be appointed as ~~herein~~ provided in this Subsection
 22 for five year terms, each member to serve until his successor is commissioned and
 23 qualified.

25 §234. Powers; duties

26 A. The Armand J. Brinkhaus, Sr., South St. Landry Community Library
 27 District is hereby declared to be a body corporate and politic, governed by the board
 28 of commissioners, with the power to sue and be sued, acquire, construct, maintain,
 29 extend, repair, and improve library equipment, fixtures, facilities, and services;
 30 ~~provided, however, that the~~ The district shall operate entirely within the framework

1 of the revenues to be derived as provided ~~herein~~ by this Part, and the library shall not
2 become a charge on the public funds of the state of Louisiana.
