1 AMENDMENT NO. 1

2 On page 1, line 2, after "(14)" and before "and" insert ", 404(F),"

3 AMENDMENT NO. 2

4 On page 1, line 3, after "relative to" and before "driver's" delete "the possession of"

5 AMENDMENT NO. 3

6 On page 1, line 4, after "cards;" and before "to authorize" insert the following:

7 "to provide with respect to reciprocity agreements relative to driver's
8 licenses;"

9 AMENDMENT NO. 4

10 On page 1, line 10, after "(14)" and before "and" insert ", 404(F),"

11 AMENDMENT NO. 5

12 On page 2, between lines 1 and 2 insert the following:

13 "§404. Operation of motor vehicles by nonresidents, students, and military
14 personnel and dependents; reciprocity agreements with
15 foreign countries

17 F. **(1)** The deputy secretary of public safety services of the Department
18 of Public Safety and Corrections is hereby authorized to promulgate rules
19 and regulations as may be necessary to enter into reciprocity agreements with
20 **jurisdictions or agencies in** foreign countries **or with foreign governments**
21 **that issue driver's licenses or the equivalent.**

22 **(2)** The rules shall specify **that the following:**

23 **(a)** ~~the~~ **The** driver's license standards of a **the licensing jurisdiction**
24 **or agency in a** foreign country **or the foreign government** shall be
25 comparable to those of this state.

26 **(b)** ~~The rules shall also require~~ foreign drivers, who are operating a
27 motor vehicle in Louisiana under such a reciprocity agreement, ~~to~~ **shall**
28 comply with the compulsory motor vehicle liability security laws of this
29 state.

30 **(c)** **The licensing requirements that the department may waive for**
31 **an applicant for a driver's license in this state.**

32 **(3)** **The issuance of a commercial driver's license pursuant to a**
33 **reciprocity agreement shall be prohibited.**

1 AMENDMENT NO. 8

2 On page 4, after line 25, insert the following:

3 "Section 3. Any existing reciprocity agreement as of the effective date
4 of this Act shall remain in full force and effect until terminated in accordance
5 with its terms. The legislature hereby specifically declares that this Act in no
6 way and to no extent is intended to nor shall it be construed in any manner
7 to impair any obligation of any reciprocity agreement in effect as of the
8 effective date of this Act."
