1 AMENDMENT NO. 1

2 On page 1, line 2, after "270(A)(3)," delete the remainder of the line and delete line 3

3 AMENDMENT NO. 2

4 On page 1, line 4, delete "of 1950, comprised of R.S. 39:100.81,"

5 AMENDMENT NO. 3

6 On page 1, line 6, change "thirty years" to "twenty years with a ten-year renewal option"

7 AMENDMENT NO. 4

8 On page 1, lines 10 and 11, delete "to provide with respect to the Community Water  
9 Enrichment Fund;" and insert "to provide for an amount to be paid to the state general fund;"

11 AMENDMENT NO. 5

12 On page 2, lines 25 and 26, delete "additional thirty-year renewal terms" and insert "one  
13 twenty-year renewal term and one ten-year renewal option"

14 AMENDMENT NO. 6

15 On page 3, line 3, after "(\$350,000,000)" insert "within six years of the approval of the  
16 amended casino operating contract"

17 AMENDMENT NO. 7

18 On page 3, delete lines 4 and 5 and insert the following:

19 "(3) The renewal terms of the casino operating contract shall contain  
20 provisions that do all of the following:"

21 AMENDMENT NO. 8

22 On page 3, between lines 16 and 17, insert the following:

23 "(c) Require the casino operator to pay a sum of forty million dollars  
24 (\$40,000,000) to the state and to the city of New Orleans. Seventy-five percent shall  
25 be paid to the state and twenty-five percent shall be paid to the city of New Orleans  
26 no later than ten days after both of the following occur:

27 (i) The Joint Legislative Committee on the Budget approves the amended  
28 casino operating contract and;

29 (ii) The New Orleans City Council approves an amended casino lease.

30 (d) Require the casino operator to pay a sum of forty million dollars  
31 (\$40,000,000) to the state and to the city of New Orleans if, prior to the end of the  
32 term of the casino operating contract, the casino operator sells the casino lease.  
33 Seventy-five percent shall be paid to the state and twenty-five percent shall be paid  
34 to the city of New Orleans no later than ten days after the execution of the sale."

5 "C. Beginning casino fiscal year April 1, 2019 to March 31, 2020 and for  
6 each casino fiscal year thereafter, the casino operator shall annually pay forty million  
7 dollars (\$40,000,000) to the state to be deposited into the state general fund."
