Amendments proposed by Representative Magee to Engrossed House Bill No. 578 by Representative Magee

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" delete the remainder of the line in its entirety and delete  
3 line 3 in its entirety and insert the following:

4 "R.S. 39:91(B)(2), (3), and (4) and (C)(2), to enact R.S. 39:91(B)(5), and to repeal  
5 R.S. 46:2691(A)(1)(b), relative to the Deepwater Horizon"

6 AMENDMENT NO. 2

7 On page 1, line 10, after "Section 1." delete the remainder of the line in its entirety and insert  
8 "R.S. 39:91(B)(2), (3), and (4) and (C)(2) are hereby amended and reenacted and R.S.  
9 39:91(B)(5) is hereby enacted"

10 AMENDMENT NO. 3

11 On page 1, delete lines 17 and 18 in their entirety and on page 2, delete lines 1 through 8 in  
12 their entirety and insert the following:

14 (2) For Fiscal Year 2019-2020, forty-five ~~Forty-five~~ percent of each such  
15 receipt of economic damages proceeds to the Budget Stabilization Fund until that  
16 fund reaches the amount statutorily mandated by R.S. 39:94.

17 (3) For Fiscal Year 2019-2020, forty-five ~~Forty-five~~ percent of each such  
18 receipt of economic damages proceeds to the Medicaid Trust Fund for the Elderly  
19 provided for in R.S. 46:2691 until an amount not to exceed seven hundred million  
20 dollars has been deposited into such fund.

21 (4) For Fiscal Year 2019-2020, ten ~~Ten~~ percent of each such receipt of  
22 economic damages proceeds to the Health Trust Fund provided for in R.S. 46:2731  
23 until an amount not to exceed thirty million dollars has been deposited into such  
24 fund.

25 (5) For Fiscal Years 2021-2026, the annual payments of fifty-three million  
26 three hundred thirty-three thousand three hundred thirty-three dollars shall be  
27 utilized as follows:"

29 On page 2, line 12, after "Years" and before "twenty-five" delete "2021-2026," and insert  
30 "2021-2025,"

31 AMENDMENT NO. 5

32 On page 3, between lines 6 and 7, insert the following:

1           ~~"(b) The monies appropriated by the legislature and disbursed from the~~  
2           ~~Deepwater Horizon Economic Damages Collection Fund shall not displace, replace,~~  
3           ~~or supplant funding for higher education. This Subparagraph shall mean that no~~  
4           ~~appropriation for any fiscal year from the Deepwater Horizon Economic Damages~~  
5           ~~Collection Fund shall be made for any purpose for which a general fund~~  
6           ~~appropriation was made in the previous year unless the total appropriations for that~~  
7           ~~fiscal year from the state general fund for such purpose exceed general fund~~  
8           ~~appropriations for the previous year. This Subparagraph shall in no way limit~~  
9           ~~general fund appropriations in excess of the minimum amounts herein established."~~

14    On page 3, line 11, after "in" and before "entirety" delete "their" and insert "its"
