Amendments proposed by Representative Marino to Reengrossed Senate Bill No. 153 by Senator Martiny

1 AMENDMENT NO. 1

2 Delete the set of amendments by the House Committee on Administration of Criminal  
3 Justice (#3080)

4 AMENDMENT NO. 2

5 On page 1, line 2, after "reenact" delete the remainder of the line, delete lines 3 through 12  
6 in their entirety, and insert the following:

7 "R.S. 27:15(B)(1) and to enact R.S. 18:1300.24 and Chapter 10 of Title 27 of the  
8 Louisiana Revised Statutes of 1950, to be comprised of R.S. 27:601 through 603,  
9 relative to sports wagering; to require an election to authorize sports wagering; to  
10 provide for the enactment of The Louisiana Sports Wagering Control Act; to provide  
11 for definitions; to provide for the duties and authority of the Louisiana Gaming  
12 Control Board with respect to the regulation of sports wagering; and to provide for  
13 related matters."

14 AMENDMENT NO. 3

15 On page 1, line 15, after "Section 1." delete the remainder of the line, delete lines 16 and 17  
16 in their entirety, and insert "R.S. 27:15(B)(1) is hereby amended and reenacted to read as  
17 follows:"

19 On page 2, delete lines 1 through 16 in their entirety

20 AMENDMENT NO. 5

21 On page 3, delete lines 4 through 29 in their entirety

22 AMENDMENT NO. 6

23 Delete pages 4 through 21 in their entirety

25 On page 22, delete lines 1 through 3 in their entirety

26 AMENDMENT NO. 8

27 On page 22, at the beginning of line 4, change "Section 4." to "Section 2."

28 AMENDMENT NO. 9

29 On page 22, delete lines 24 through 29 in their entirety and insert the following:

1 "Section 3. Chapter 10 of Title 27 of the Louisiana Revised Statutes of 1950, to be  
2 comprised of R.S. 27:601 through 603 is hereby enacted to read as follows:

3 **CHAPTER 10. SPORTS WAGERING CONTROL ACT**

4 **§601. Title**

5 **This Chapter shall be cited and referred to as "The Louisiana Sports**  
6 **Wagering Control Act".**

7 **§602. Definitions**

8 **Unless the context clearly indicates otherwise, when used in this Chapter,**  
9 **the following terms shall mean:**

10 **(1) "Board" has the same meaning as that term has in R.S. 27:3.**

11 **(2) "Division" has the same meaning as that term has in R.S. 27:3.**

12 **(3) "Game" means a wager on a sports event or sporting event approved**  
13 **by the board.**

14 **(4)(a) "Sports event" or "sporting event" means any professional sport**  
15 **or athletic event, any Olympic or international sports competition event, any**  
16 **collegiate sport or athletic event, or any portions thereof, including but not**  
17 **limited to the individual performance statistics of athletes in a sports event or**  
18 **combination of sports events. "Sports event" or "sporting event" shall not**  
19 **include a prohibited event or fantasy sports activity. A prohibited event shall**  
20 **include any high school sports event.**

21 **(b) "Professional sport or athletic event" as used in Subparagraph (a) of**  
22 **this Paragraph means an event at which two or more persons participate in a**  
23 **sport or athletic event and receive compensation in excess of actual expenses for**  
24 **their participation in such event.**

25 **(5)(a) "Sports wagering" means the business of accepting wagers on a**  
26 **sports event approved by the board, provided all of the following conditions are**  
27 **met:**

28 **(i) The outcome of the sports event can be verified.**

29 **(ii) The outcome of the sports event can be generated by a reliable and**  
30 **independent process.**

31 **(iii) The outcome of the sports event is not affected by any wager placed.**

32 **(iv) The sports event is conducted in conformity with applicable laws,**  
33 **rules, and regulations, including the rules governing the sports event.**

34 **(v) The wager shall only be accepted from persons twenty-one years of**  
35 **age or older.**

36 **(b) The term "sports wagering" may also include proposition wagers on**  
37 **novelty occurrences or nonoccurrences, or individual players over a broad**  
38 **spectrum of possibilities within a sports event that are not dependent on the**  
39 **final outcome of the sports event as approved by the board.**

40 **§603. Gaming Control Board; duties and powers**

41 **A. The board shall perform the duties and functions as authorized by**  
42 **the provisions of this Chapter and the regulatory authority with respect to the**  
43 **regulation of sports wagering as provided by R.S. 27:15.**

44 **B. The board shall adopt, pursuant to the Administrative Procedure**  
45 **Act, all rules necessary to implement, administer, and regulate sports wagering**  
46 **as authorized in this Chapter."**
