Provides relative to procurement limits for purchases of materials and supplies by public entities

Proposed law changes the purchasing limit for materials and supplies **from** \$30,000 **to** \$60,000 for all purchases of any materials and supplies. Proposed law changes the purchasing range requiring quotes **from** \$10,000 or more but less than \$30,000 **to** \$20,000 or more but less than \$60,000.
