EXPENDITURE EXPLANATION

There will be an increase in local expenditures to the 22nd Judicial District Court Judicial Expense Fund for the addition of a second commissioner. The increased expenditures include the salary (\$75,000) and related benefits (\$22,750) for the second commissioner for an annual cost of \$97,750. Expenditures in the out years include costs for salary adjustments.

The court will also incur increased annual costs for the following: \$25,000 for additional court reporter services; \$1,000 for continuing legal education; \$1,000 for travel expenses; and \$500 for office expenses.
