HOLIDAYS: Designates Dr. Martin Luther King's birthday as a mandatory state holiday

1 AN ACT

2 To amend and reenact R.S. 1:55(B)(1)(a) and (2), relative to legal holidays observed by the
3 departments of the state; to provide that Dr. Martin Luther King, Jr.'s birthday shall
4 be a state legal holiday; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 1:55(B)(1)(a) and (2) are hereby amended and reenacted to read as
7 follows:

8 §55. Days of public rest, legal holidays, and half-holidays

9 * * *

10 B. Legal holidays shall be observed by the departments of the state as follows:

11 (1)(a) Insofar as may be practicable in the administration of the government,
12 no employee shall work on New Year's Day, Dr. Martin Luther King, Jr.'s Birthday
13 which shall be observed on the third Monday of January of each year or in conjunction
14 with the day of the federal observance, Mardi Gras Day, Good Friday, Independence
15 Day, Labor Day, Veterans' Day, Thanksgiving Day, Christmas Day, Inauguration Day

1 once in every four years in the city of Baton Rouge, or General Election Day every
2 two years.

DIGEST

Abstract: Provides that Dr. Martin Luther King, Jr.'s birthday shall be a legal holiday and observed by the departments of the state.

Present law provides that insofar as may be practicable in the administration of the government, legal holidays shall be observed by the departments of the state, and no employee shall work on New Year's Day, Mardi Gras Day, Good Friday, Independence Day, Christmas Day, Inauguration Day once in every four years in the city of Baton Rouge, or General Election Day every two years.

Present law authorizes the governor to proclaim two additional legal holidays each year, one of which is required to be National Memorial Day and requires that the governor call as a state holiday at least once every two years the birthday of Dr. Martin Luther King, Jr.

Proposed law enumerates Dr. Martin Luther King, Jr.'s birthday as a legal holiday required to be observed by the departments of the state and which shall be observed on the third Monday of January of each year or in conjunction with the day of the federal observance.
