Amendments proposed by Senate Committee on Revenue and Fiscal Affairs to Original Senate Bill No. 228 by Senator Gray Evans

1 AMENDMENT NO. 1

2 On page 1, line 2, change "R.S. 47:297.8(C)" to "R.S. 47:297.13"

3 AMENDMENT NO. 2

4 On page 1, line 3, change "or" to "who are also"

5 AMENDMENT NO. 3

6 On page 1, line 6, change "R.S. 47:297.8(C)" to "R.S. 47:297.13"

7 AMENDMENT NO. 4

8 On page 1, delete lines 7 and 8, and insert: "**§297.13. Housing credit for low-income**
9 **homeowners**"

10 AMENDMENT NO. 5

11 On page 1, line 9, change "**C.**" to "**A.**"

12 AMENDMENT NO. 6

13 On page 1, line 10, after "**homeowners**" change "**and**" to "**who are also**"

14 AMENDMENT NO. 7

15 On page 1, line 11, delete "**not residing in subsidized housing**" and change "**needs to**" to
16 "**needs for**"

17 AMENDMENT NO. 8

18 On page 1, line 14, change "**Subsection**" to "**Section**"

19 AMENDMENT NO. 9

20 On page 1, delete line 17, and insert "**the taxpayer's primary residence.**"

21 AMENDMENT NO. 10

22 On page 2, delete lines 1 through 4, and insert:

23 **"(b) "Housing costs" means the expenses of mortgage, rent, property**
24 **insurance, property taxes, and utilities."**

25 AMENDMENT NO. 11

26 On page 2, line 6, change "**two hundred**" to "**two hundred fifty**"

27 AMENDMENT NO. 12

28 On page 2, delete lines 8 through 13

1 AMENDMENT NO. 13

2 On page 2, delete line 14, and insert "**B. For tax**"

3 AMENDMENT NO. 14

4 On page 2, line 16, after "**Chapter**" delete the remainder of the line, delete lines 17 through
5 21, and insert:

6 **"for a homeowner who is also a residential lessee, and who meets the income**
7 **criteria provided for in Subparagraph (A)(2)(c) of this Section, not to exceed**
8 **three hundred thirty dollars per tax year.**

9 Section 2. This Act shall become effective upon signature by the governor
10 or, if not signed by the governor, upon expiration of the time for bills to become law
11 without signature by the governor, as provided by Article III, Section 18 of the
12 Constitution of Louisiana. If vetoed by the governor and subsequently approved by
13 the legislature, this Act shall become effective on the day following such approval."
