

HOUSE COMMITTEE AMENDMENTS

Amendments proposed by House Committee on Appropriations to Reengrossed Senate Bill No. 34 by Senator Chaisson

1 AMENDMENT NO. 1

2 On page 1, line 2, change "R.S. 39:75(E)(5)," to "R.S. 39:75(E)(5) and (6),"

3 AMENDMENT NO. 2

4 On page 1, line 8, after "next fiscal year;" and before "to repeal" insert "to provide for
5 legislative approval in certain circumstances;"

6 AMENDMENT NO. 3

7 On page 2, at the end of line 10, add the following:

8 **"For the purposes of this Subparagraph, the governor may direct the**
9 **commissioner of administration to reduce any appropriation or**
10 **allocation for the executive branch of state government an amount not**
11 **to exceed five percent in the aggregate of the amount appropriated or**
12 **allocated from a fund that is derived from the imposition, assessment, or**
13 **collection of a fee."**

14 AMENDMENT NO. 4

15 On page 2, at the end of line 21, insert the following:

16 **"For the purposes of this Paragraph, an amount not to exceed five**
17 **percent in the aggregate of the amount appropriated or allocated from**
18 **a fund that is derived from the imposition, assessment, or collection of**
19 **a fee in the current fiscal year shall be available for appropriation in the**
20 **next fiscal year for a purpose other than as specifically authorized for**
21 **that fund."**

22 AMENDMENT NO. 5

23 On page 2, at the end of line 29, add the following:

24 **"For the purposes of this Paragraph, an amount not to exceed five**
25 **percent in the aggregate of the amount appropriated or allocated from**
26 **a fund that is derived from the imposition, assessment, or collection of**
27 **a fee in the current fiscal year shall be available for appropriation in the**
28 **next fiscal year for a purpose other than as specifically authorized for**
29 **that fund."**

30 AMENDMENT NO. 6

31 On page 3, line 2, change "R.S. 39:75(E)(5) is hereby" to "R.S. 39:75(E)(5) and (6) are
32 hereby"

33 AMENDMENT NO. 7

34 On page 3, delete lines 7 through 15 in their entirety and insert the following:

1 "(5) Solely for the purpose of projected deficits as provided in
2 Article VII, Section 10(F) of the Constitution of Louisiana and this
3 Paragraph for the development of the budget estimate and enactment of
4 the budget for the next fiscal year, the official forecasts of recurring
5 revenues for Fiscal Year 2008-2009 through Fiscal Year 2012-2013 shall
6 include federal funds received by the state as a result of the American
7 Recovery and Reinvestment Act of 2009. Federal funds received by the
8 state as a result of the American Recovery and Reinvestment Act of 2009
9 shall be included in the official forecast for each fiscal year in proportion
10 to the amount of such funds that would be available for appropriation
11 in such fiscal year. Federal funds received by the state as a result of the
12 American Recovery and Reinvestment Act of 2009 shall not be included
13 in the official forecast for any other purpose including the Budget
14 Stabilization Fund as provided in Article VII, Section 10.3 of the
15 Constitution of Louisiana or R.S. 39:94."

16 AMENDMENT NO. 8

17 On page 3, line 17, after "by the" and before "legislature" insert "Joint Legislative
18 Committee on the Budget and subsequently by the"
