Amendments proposed by Senate Committee on Finance to Engrossed House Bill No. 802  
by Representative Fannin

1 AMENDMENT NO. 1

2 On page 1, line 14, between "Million" and "Dollars" insert "Nine Hundred Thousand"

3 AMENDMENT NO. 2

4 On page 7, between lines 8 and 9, insert the following:

5 "Section 8. The state treasurer is hereby authorized and directed to transfer from the  
6 state general fund for Fiscal Year 2008-2009 receipts of Four Million Nine Hundred  
7 Twenty-Nine Thousand Six Hundred Ten Dollars to be deposited in and credited to the  
8 Overcollections Fund.

9 Section 9. A. Notwithstanding any provision of law to the contrary, the state treasurer  
10 is hereby authorized and directed to transfer Two Hundred Fifty-Nine Thousand Eight  
11 Hundred Fifty Dollars from the Municipal Fire and Police Civil Service Operating Fund to  
12 the Overcollections Fund.

13 B. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
14 authorized and directed to transfer One Million Seven Hundred Sixty-Three Thousand  
15 Fifty-Five Dollars from the Rural Development Fund to the Overcollections Fund.

16 C. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
17 authorized and directed to transfer One Hundred Thirty-One Thousand Eight Hundred  
18 Seventy Dollars from the Casino Gaming Proceeds Fund to the Overcollections Fund.

19 D. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
20 authorized and directed to transfer One Hundred Twenty-Three Thousand Two Hundred  
21 Ninety-One Dollars from the Underground Damages Prevention Fund to the Overcollections  
22 Fund.

23 E. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
24 authorized and directed to transfer Two Million Nine Hundred Twelve Thousand Eight  
25 Hundred Eighty Dollars from the Louisiana Fire Marshal Fund to the Overcollections Fund.

26 F. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
27 authorized and directed to transfer Six Hundred Twenty-Three Thousand One Hundred  
28 Forty-Four Dollars from the Louisiana Fire Safety and Property Protection Trust Fund to the  
29 Overcollections Fund.

30 G. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
31 authorized and directed to transfer Four Hundred Thousand Sixty-Two Dollars from the  
32 Right to Know Fund to the Overcollections Fund.

33 H. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
34 authorized and directed to transfer One Thousand Six Hundred Seventy-Two Dollars from  
35 the Pet Overpopulation Fund to the Overcollections Fund.

36 I. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
37 authorized and directed to transfer Three Hundred Nineteen Thousand Three Hundred Three  
38 Dollars from the Louisiana Manufactured Housing Commission Fund to the Overcollections  
39 Fund.

1 J. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
2 authorized and directed to transfer One Million Five Hundred Sixty-Eight Thousand Six  
3 Hundred Thirteen Dollars from the Insurance Fraud Investigation Fund to the  
4 Overcollections Fund.

5 K. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
6 authorized and directed to transfer Two Hundred Fifty-Three Thousand Three Hundred  
7 Sixty-Two Dollars from the Louisiana Environmental Education Fund to the Overcollections  
8 Fund.

9 L. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
10 authorized and directed to transfer Eighteen Million Dollars from the Mineral Resources  
11 Operation Fund to the Overcollections Fund.

12 M. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
13 authorized and directed to transfer One Million Dollars from the Oil and Gas Regulatory  
14 Fund to the Overcollections Fund.

15 N. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
16 authorized and directed to transfer Thirty-Seven Thousand Nine Hundred Fifty-One Dollars  
17 from the Tobacco Regulation Enforcement Fund to the Overcollections Fund.

18 O. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
19 authorized and directed to transfer One Hundred Ninety-One Thousand Three Hundred  
20 Seventeen Dollars from the Lead Hazard Reduction Fund to the Overcollections Fund.

21 P. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
22 authorized and directed to transfer Fifty Thousand Dollars from the Manufactured Home Tax  
23 Fairness Fund to the Overcollections Fund.

24 Q. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
25 authorized and directed to transfer Three Million Three Hundred Sixty-Two Thousand Nine  
26 Hundred Thirty-Six Dollars from the Utility and Carrier Inspection and Supervision Fund  
27 to the Overcollections Fund.

28 R. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
29 authorized and directed to transfer Two Hundred Fifteen Thousand Six Hundred Ten Dollars  
30 from the Telephonic Solicitation Relief Fund to the Overcollections Fund.

31 S. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
32 authorized and directed to transfer One Hundred Forty-Three Thousand Five Hundred  
33 Thirty-Eight Dollars from the Administrative Fund of the Department of Insurance to the  
34 Overcollections Fund.

35 T. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
36 authorized and directed to transfer Twenty-Six Thousand Eight Hundred Fifteen Dollars  
37 from the Agricultural Products Processing Development Fund to the Overcollections Fund.

38 U. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
39 authorized and directed to transfer Five Hundred Seven Thousand Three Hundred Sixty-Nine  
40 Dollars from the Department of Justice Debt Collection Fund to the Overcollections Fund.

41 V. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
42 authorized and directed to transfer Five Thousand Four Hundred Seventy-Two Dollars from  
43 the General Aviation and Reliever Airport Maintenance Grant Program Fund to the  
44 Overcollections Fund.

45 W. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
46 authorized and directed to transfer Two Thousand Eight Hundred Seventy-One Dollars from  
47 the Railroad Crossing Safety Fund to the Overcollections Fund.

1 X. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
 2 authorized and directed to transfer Four Thousand Three Hundred Seventy-Three Dollars  
 3 from the School and District Accountability Rewards Fund to the Overcollections Fund.

4 Y. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
 5 authorized and directed to transfer Twenty-Nine Thousand Two Hundred Forty Dollars from  
 6 the Teacher Educational Aid for Children Fund to the Overcollections Fund.

7 Z. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
 8 authorized and directed to transfer Two Hundred Twenty-Eight Thousand One Hundred One  
 9 Dollars from the Variable Earnings Transaction Fund to the Overcollections Fund.

10 AA. Notwithstanding any provision of law to the contrary, the state treasurer is  
 11 hereby authorized and directed to transfer Two Hundred Two Thousand Eight Hundred  
 12 Sixty-One Dollars from the Fraud Detection Fund to the Overcollections Fund.

13 BB. Notwithstanding any provision of law to the contrary, the state treasurer is  
 14 hereby authorized and directed to transfer One Hundred Thousand Twenty-Six Dollars from  
 15 the Vital Records Conversion Fund to the Overcollections Fund.

16 CC. Notwithstanding any provision of law to the contrary, the state treasurer is  
 17 hereby authorized and directed to transfer Five Million Thirty-Nine Thousand One Hundred  
 18 Thirty-Eight Dollars from the Louisiana Health Care Redesign Fund to the Overcollections  
 19 Fund.

20 DD. Notwithstanding any provision of law to the contrary, the state treasurer is  
 21 hereby authorized and directed to transfer Seven Hundred Nine Thousand Two Hundred  
 22 Sixty-Six Dollars from the Compulsive and Problem Gaming Fund to the Overcollections  
 23 Fund.

24 EE. Notwithstanding any provision of law to the contrary, the state treasurer is  
 25 hereby authorized and directed to transfer Three Hundred Thirty-Eight Thousand Six  
 26 Hundred Ninety-Four Dollars from the Director of Workers' Compensation Revolving Fund  
 27 to the Overcollections Fund.

28 FF. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
 29 authorized and directed to transfer Three Million One Hundred Ninety-Three Thousand Four  
 30 Hundred Twelve Dollars from the Employment Security Administration Account to the  
 31 Overcollections Fund.

32 GG. Notwithstanding any provision of law to the contrary, the state treasurer is  
 33 hereby authorized and directed to transfer Nine Hundred Fifty Thousand Dollars from the  
 34 Incentive Fund to the Overcollections Fund.

35 Section 10. A. Notwithstanding any provision of law to the contrary, the state  
 36 treasurer is hereby authorized and directed to transfer Twenty-One Thousand Eight Hundred  
 37 Twenty-Five Dollars from the Conservation Fund to the Louisiana Duck License Stamp and  
 38 Print Fund.

39 B. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
 40 authorized and directed to transfer Sixty-Five Thousand Fourteen Dollars from the  
 41 Conservation Fund to the Wildlife Habitat and Natural Heritage Fund.

42 C. Notwithstanding any provision of law to the contrary, the state treasurer is hereby  
 43 authorized and directed to transfer Three Thousand Seven Hundred Forty-Three Dollars  
 44 from the Conservation Fund to the Louisiana Wild Turkey Stamp Fund.

45 Section 11. All bridge loan funding extended to the Department of Education from  
 46 the State Emergency Response Fund due no later than the end of the 2008-2009 fiscal year  
 47 pursuant to Act No. 196 of the 2007 Regular Session of the Legislature is extended to the  
 48 end of the 2009-2010 fiscal year."
