

SENATE BILL NO. 182

BY SENATOR CROWE

Prefiled pursuant to Article III, Section 2(A)(4)(b)(i) of the Constitution of Louisiana.

1 AN ACT

2 To authorize and provide for the transfer of certain state property; to authorize the transfer
3 of certain state property in St. Tammany Parish; to provide for the property
4 description; to provide for reservation of mineral rights; to provide terms and
5 conditions; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 **Section 1. The Board of Supervisors of Community and Technical Colleges,**
8 **notwithstanding any other provision of law to the contrary, is hereby authorized and**
9 **empowered to convey, transfer, assign, and deliver any interest, excluding mineral**
10 **rights, the state may have to all or any portion of the following described parcels of**
11 **properties to the St. Tammany Parish School Board:**

12 **A. A certain tract of land, including all improvements located thereon,**
13 **situated and lying in Section 44, Township 9, South, Range 14 East, City of**
14 **Slidell, Ninth Ward, St. Tammany Parish, Louisiana, containing approximately**
15 **5 acres, more or less, and being the same property acquired by the Louisiana**
16 **State Board of Education from Slidell Brick & Tile, Inc., by Act of Donation**
17 **dated August 8, 1970, registered in COB 581, folio 380. This transfer is**
18 **contingent upon written consent by Slidell Brick & Tile, Inc. or its successors.**

19 **B. A certain tract of land, including all improvements located thereon,**
20 **situated and lying in Section 44, Township 9 South, Range 14 East, St.**
21 **Tammany Parish, Louisiana, containing approximately 7.5 acres, more or less,**
22 **and being the same property acquired by the State of Louisiana from Mr.**
23 **Claude W. Schneider, Mrs. Bernice Schneider, and Matthew P. Schneider, Jr.,**
24 **by act of cash sale dated October 31, 1974, registered in COB 743, folio 314.**

25 **C. A certain tract of land, including all improvements located thereon,**
26 **situated and lying in Section 44, Township 9 South, Range 14 East, St.**

1 Tammany Parish, Louisiana, containing approximately 7.5 acres, more or less,
 2 and being the same property acquired by the State of Louisiana from Mr.
 3 Claude W. Schneider, Mrs. Bernice Schneider, and Matthew P. Schneider, Jr.,
 4 by act of donation inter vivos dated October 31, 1974, registered in COB 743,
 5 folio 278.

6 Section 2. The Board of Supervisors of Community and Technical Colleges is
 7 hereby authorized to enter into such agreements, covenants, conditions, and
 8 stipulations and to execute such documents as necessary to properly effectuate any
 9 conveyance, transfer, assignment, or delivery of title, excluding mineral rights, to the
 10 property described in Section 1, and as more specifically described in any such
 11 agreements entered into and documents executed by and between the Board of
 12 Supervisors of Community and Technical Colleges and the St. Tammany Parish School
 13 Board, in exchange of consideration proportionate to the appraised value of the
 14 properties.

15 Section 3. The proceeds of any sale of the above parcels of properties shall be
 16 dedicated to the construction and maintenance of a vocational-technical school in the
parish of St. Tammany.
