AN ACT

To amend and reenact R.S.39: 94(C)(4) and R.S. 47:302.23(B)(1), to enact Subpart Q, to be comprised of R.S. 39:100.121, Subpart Q-1, to be comprised of R.S. 39:100.122, Subpart Q-2, to be comprised of R.S. 39:100.123, Subpart Q-3, to be comprised of R.S. 39:100.124, Subpart Q-4, to be comprised of R.S. 39:100.125 of Part II-A of Chapter 1 of Subtitle I of Title 39 of the Louisiana revised Statutes of 1950; and to repeal R.S. 22:2371, relative to state funds; to abolish the Insure Louisiana Incentive Program Fund; to provide for the transfer, dedication, use, and appropriation as specified of certain treasury funds; to provide for the uses of monies in the Vermilion Parish Visitor Enterprise Fund; to establish the Hurricane Recovery Health Insurance Premium Fund; to establish the Center of Excellence for Autism Spectrum Disorder Fund; to create the Walking the Walk for Our Kids Fund; to create the Technology Commercialization Fund; to create the Statewide Education Facilities Fund; to provide for effective dates; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 39:94(C)(4) is hereby amended and reenacted and Subpart Q, comprised of R.S. 39:100.121, Subpart Q-1, comprised of R.S. 39:100.122, Subpart Q-2, comprised of R.S. 39:100.123, Subpart Q-3, comprised of R.S. 39:100.124, and Subpart Q-4, comprised of R.S. 39:100.125 are hereby enacted to read as follows:

§94. Budget Stabilization Fund

* * *

C. The money in the fund shall not be available for appropriation except under the following conditions:

* * *

1 subsidy of health insurance premiums. Distributions to the school boards shall be
2 as follows:

3 (a) Four and nine-tenths percent to the Cameron Parish School Board.

4 (b) Ten and four-tenths percent to the Plaquemines Parish School Board.

5 (c) Twenty-one and four-tenths percent to the St. Bernard Parish School
6 Board.

7 D. All unexpended and unencumbered monies in the fund at the end of the
8 fiscal year shall remain in the fund. The monies in the fund shall be invested by the
9 state treasurer in the same manner as monies in the state general fund, and interest
10 earned on the investment of these monies shall be credited to the state general fund.

11 SUBPART Q-1. CENTER OF EXCELLENCE FOR AUTISM SPECTRUM

12 DISORDER FUND

13 §100.122. Center of Excellence for Autism Spectrum Disorder Fund

14 A. There is hereby established in the state treasury, as a special fund, the
15 Center of Excellence for Autism Spectrum Disorder Fund, hereinafter referred to as
16 the "fund".

17 B. The source of monies deposited into the fund shall be any monies
18 appropriated annually by the legislature including donations, gifts, grants, or any
19 other monies which may be provided by law. All unexpended and unencumbered
20 monies in the fund at the end of the fiscal year shall remain in the fund. The monies
21 in the fund shall be invested by the state treasurer in the same manner as monies in
22 the state general fund, and interest earned on the investment of monies shall be
23 credited to the fund.

24 C. The monies in the fund shall be appropriated and used solely to pay costs
25 and expenses associated with the establishment and operation of a center of
26 excellence for autism spectrum disorder by the office for citizens with developmental
27 disabilities within the Department of Health and Hospitals.

1 SUBPART Q-2. WALKING THE WALK FOR OUR KIDS FUND

2 §100.123. Walking the Walk for Our Kids Fund

3 A. There is hereby established in the state treasury, as a special fund, the
 4 Walking the Walk for Our Kids Fund, hereinafter referred to as the "fund".

5 B. The source of monies deposited into the fund shall be any monies
 6 appropriated annually by the legislature including donations, gifts, grants, or any
 7 other monies which may be provided by law. All unexpended and unencumbered
 8 monies in the fund at the end of the fiscal year shall remain in the fund. The monies
 9 in the fund shall be invested by the state treasurer in the same manner as monies in
 10 the state general fund, and interest earned on the investment of monies shall be
 11 credited to the fund.

12 C. The monies in the fund shall be appropriated and used solely for the
 13 diagnosis, prevention, and treatment of childhood obesity.

14 SUBPART Q-3. TECHNOLOGY COMMERCIALIZATION FUND

15 §100.124. Technology Commercialization Fund

16 A. The Technology Commercialization Fund, hereinafter referred to as the
 17 "fund", is hereby established as a special fund in the state treasury for purposes of
 18 supporting a competitive grants program for commercialization of technologies
 19 developed at accredited Louisiana institutions of higher education and academic
 20 research centers as provided in Subsection C of this Section. Monies shall be
 21 transferred, subject to an annual appropriation by the legislature, into the Technology
 22 Commercialization Fund.

23 B. Monies in the fund shall be invested by the state treasurer in the same
 24 manner as those in the state general fund and interest earnings on the investment of
 25 monies in the fund shall be credited to the fund. Any unencumbered or unexpended
 26 monies in the fund at the end of the fiscal year shall remain in the fund.

27 C. Subject to an annual appropriation by the legislature, monies in the fund
 28 shall be used by the Louisiana Economic Development Corporation, hereinafter
 29 referred to as the "corporation", to provide for a competitive grants program for the
 30 advancement of commercialization of technologies developed at accredited

1 receives an equal share of the monies. Monies shall be allocated only to a public or
 2 quasi-public entity of the state of Louisiana. For the purposes of this Section,
 3 "quasi-public entity" shall mean an entity that is recognized as a tax-exempt
 4 organization under the provisions of the Internal Revenue Code. In addition,
 5 quasi-public entities shall demonstrate that the entity is in good standing with the
 6 Louisiana secretary of state; public entities shall demonstrate compliance with audit
 7 requirements provided by law. In the event that any entity above ceases to exist, any
 8 unexpended and unencumbered monies allocated to that entity shall be distributed
 9 equally among the remaining entities.

10 * * *

11 Section 3. R.S. 22:2371 is hereby repealed in its entirety.

12 Section 4. Notwithstanding any provision of law to the contrary, the Insure
 13 Louisiana Incentive Program Fund is hereby abolished on the effective date of this Section.
 14 At such time, the treasurer is authorized and directed to transfer any unexpended,
 15 unencumbered monies remaining in the fund for deposit in and credit to the state general
 16 fund.

17 Section 5. The state treasurer is hereby authorized and directed to transfer Three
 18 Million Nine Hundred Thousand Dollars from the Incentive Fund to be deposited to and
 19 credited in the state general fund.

20 Section 6. In accordance with the Deficit Reduction Plan authorized by R.S. 39:75
 21 (C) and implemented and approved by the governor in issuing Executive Order No. BJ
 22 2008-114 and by action of the Joint Legislative Committee on the Budget on January 9,
 23 2009, the state treasurer is authorized and directed to transfer from the following funds and
 24 in the amounts specified Twenty-Four Million Three Hundred Seventy-Eight Thousand
 25 Fifty-Six Dollars to the state general fund:

16 to the Overcollections Fund.

12 authorized and directed to transfer Twenty-Nine Thousand Two Hundred Forty Dollars from
13 the Teacher Educational Aid for Children Fund to the Overcollections Fund.

14 Z. Notwithstanding any provision of law to the contrary, the state treasurer is hereby
15 authorized and directed to transfer Two Hundred Twenty-Eight Thousand One Hundred One
16 Dollars from the Variable Earnings Transaction Fund to the Overcollections Fund.

17 AA. Notwithstanding any provision of law to the contrary, the state treasurer is
18 hereby authorized and directed to transfer Two Hundred Two Thousand Eight Hundred
19 Sixty-One Dollars from the Fraud Detection Fund to the Overcollections Fund.

20 BB. Notwithstanding any provision of law to the contrary, the state treasurer is
21 hereby authorized and directed to transfer One Hundred Thousand Twenty-Six Dollars from
22 the Vital Records Conversion Fund to the Overcollections Fund.

23 CC. Notwithstanding any provision of law to the contrary, the state treasurer is
24 hereby authorized and directed to transfer Five Million Thirty-Nine Thousand One Hundred
25 Thirty-Eight Dollars from the Louisiana Health Care Redesign Fund to the Overcollections
26 Fund.

27 DD. Notwithstanding any provision of law to the contrary, the state treasurer is
28 hereby authorized and directed to transfer Seven Hundred Nine Thousand Two Hundred
29 Sixty-Six Dollars from the Compulsive and Problem Gaming Fund to the Overcollections
30 Fund.

1 EE. Notwithstanding any provision of law to the contrary, the state treasurer is
2 hereby authorized and directed to transfer Three Hundred Thirty-Eight Thousand Six
3 Hundred Ninety-Four Dollars from the Director of Workers' Compensation Revolving Fund
4 to the Overcollections Fund.

5 FF. Notwithstanding any provision of law to the contrary, the state treasurer is hereby
6 authorized and directed to transfer Three Million One Hundred Ninety-Three Thousand Four
7 Hundred Twelve Dollars from the Employment Security Administration Account to the
8 Overcollections Fund.

9 GG. Notwithstanding any provision of law to the contrary, the state treasurer is
10 hereby authorized and directed to transfer Nine Hundred Fifty Thousand Dollars from the
11 Incentive Fund to the Overcollections Fund.

12 Section 14. A. Notwithstanding any provision of law to the contrary, the state
13 treasurer is hereby authorized and directed to transfer Twenty-One Thousand Eight Hundred
14 Twenty-Five Dollars from the Conservation Fund to the Louisiana Duck License Stamp and
15 Print Fund.

16 B. Notwithstanding any provision of law to the contrary, the state treasurer is hereby
17 authorized and directed to transfer Sixty-Five Thousand Fourteen Dollars from the
18 Conservation Fund to the Wildlife Habitat and Natural Heritage Fund.

19 C. Notwithstanding any provision of law to the contrary, the state treasurer is hereby
20 authorized and directed to transfer Three Thousand Seven Hundred Forty-Three Dollars
21 from the Conservation Fund to the Louisiana Wild Turkey Stamp Fund.

22 Section 15. All bridge loan funding extended to the Department of Education from
23 the FEMA Reimbursement Fund due no later than the end of the 2008-2009 Fiscal Year
24 pursuant to Act No. 196 of the 2007 Regular Session of the Legislature is extended to the
25 end of the 2009-2010 Fiscal Year.

26 Section 16. Sections 6, 7, 8, 9, 12, 13, 14, 15, 16, and 17 of this Act shall become
27 effective upon signature of this Act by the governor or, if not signed by the governor, upon
28 expiration of the time for bills to become law without signature by the governor, as provided
29 by Article III, Section 18 of the Constitution of Louisiana. If this Act is vetoed by the

1 governor and subsequently approved by the legislature, Sections 6, 7, 8, 9, 12, 13, 14, 15,
2 16, and 17 of this Act shall become effective on the day following such approval.

3 Section 17. Sections 1, 2, 3, 4, 5, 10, and 11 of this Act shall become effective on
4 July 1, 2009; if vetoed by the governor and subsequently approved by the legislature,
5 Sections 1, 2, 3, 4, 5, 10, and 11 of this Act shall become effective on July 1, 2009, or on the
6 day following such approval by the legislature, whichever is later.
