SENATE BILL NO. 439

PUBLIC PROPERTY. Authorizes the Department of Culture, Recreation and Tourism to accept donation of certain immovable property in Caldwell Parish. (gov sig)

1 AN ACT

2 To authorize and provide for the acceptance of the donation of certain property in Caldwell
3 Parish to the state of Louisiana, through the Department of Culture, Recreation and
4 Tourism; to provide for an effective date; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 **Section 1. Notwithstanding any other provision of law to the contrary, the**
7 **secretary of the Department of Culture, Recreation and Tourism, with the approval of**
8 **the commissioner of administration in accordance with R.S. 39:11, is hereby authorized**
9 **and empowered to accept, on behalf of the state of Louisiana, the donation of all or part**
10 **of the following described immovable properties located in Caldwell Parish, state of**
11 **Louisiana, owned by the Bayou DeChene Reservoir Commission:**

12 **Certain tracts of land situated in Sections 13, 14, 23, 24, and 38, Township 13**
13 **North, Range 3 East, Caldwell Parish, Louisiana.**

14 **Section 2. Such donation shall include such land, buildings, and improvements,**
15 **rights, ways, servitudes, privileges, and advantages appurtenant thereto, as agreed**
16 **upon in the action of donation.**

17 **Section 3. The secretary of the Department of Culture, Recreation and Tourism,**

1 **or his designated representative, on behalf of the state of Louisiana, is authorized to**
2 **negotiate the terms and conditions of the donation and to execute such documents, to**
3 **enter into such agreements, covenants, conditions, and stipulations, and to perform**
4 **such other acts as are necessary to properly effectuate any donation, transfer,**
5 **assignment, and delivery of title, to the property as more specifically described in any**
6 **such agreement entered into and documents executed by and between the secretary of**
7 **the Department of Culture, Recreation and Tourism and Bayou DeChene Reservoir**
8 **Commission.**

9 Section 4. This Act shall become effective upon signature of the governor or, if not
10 signed by the governor, upon expiration of the time for bills to become law without signature
11 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
12 vetoed by the governor and subsequently approved by the legislature, this Act shall become
13 effective on the day following such approval.

DIGEST

Authorizes the secretary of the Department of Culture, Recreation and Tourism, with the concurrence of the commissioner of administration, to accept, on behalf of the state, the donation of all or part of the immovable property located in Caldwell Parish, state of Louisiana, owned by the Bayou DeChene Reservoir Commission.

Effective upon the signature of the governor or lapse of time for gubernatorial action.
