SENATE BILL NO. 105

WORKFORCE COMMISSION. Re-creates the Louisiana Workforce Commission.
(6/30/10)

1 AN ACT

2 To enact R.S. 49:191(5) and to repeal R.S. 49:191(3)(g), relative to the Louisiana Workforce
3 Commission; to provide for the re-creation of the Louisiana Workforce Commission
4 and the statutory entities made a part of the commission by law; to provide for the
5 effective termination date for all statutory authority for the existence of such
6 statutory entities; and to provide for related matters.

7 Be it enacted by the Legislature of Louisiana:

8 Section 1. Pursuant to R.S. 49:193, the Louisiana Workforce Commission and the
9 statutory entities made a part of the department by law shall be re-created effective June 30,
10 2010, and all statutory authority therefor is continued in accordance with the provisions of
11 Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

12 Section 2. All statutory authority for the existence of the Louisiana Workforce
13 Commission and the statutory entities made a part of the department as re-created by Section
14 1 of this Act shall cease as of July 1, 2016, pursuant to R.S. 49:191. However, the Louisiana
15 Workforce Commission may be re-created prior to such date in accordance with the
16 provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.

17 Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that

1 those provisions are in conflict with the provisions of this Act.

2 Section 4. R.S. 49:191(5) is hereby enacted to read as follows:

3 §191. Termination of legislative authority for existence of statutory entities;
4 phase-out period for statutory entities; table of dates

5 Notwithstanding any termination dates set by any previous Act of the
6 legislature, the statutory entities set forth in this Section shall begin to terminate their
7 operations on July first of each of the following years, and all legislative authority
8 for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of
9 July first of the following year, which shall be the termination date:

11 **(5) July 1, 2014:**

12 **(a) The Louisiana Workforce Commission and all statutory entities**
13 **made a part of the department by law.**

14 Section 5. R.S. 49:191(3)(g) is hereby repealed.

15 Section 6. This Act shall become effective on June 30, 2010; if vetoed by the
16 governor and subsequently approved by the legislature, this Act shall become effective on
17 June 30, 2010, or on the day following such approval by the legislature, whichever is later.

DIGEST

Riser (SB 105)

Present law provides for the Louisiana Workforce Commission (LWC) to begin to terminate operations on July 1, 2010, and to cease existence on July 1, 2011.

Proposed law re-creates the LWC and extends its operation to July 1, 2014, at which time operations should be terminated.

Proposed law extends the existence of LWC until July 1, 2015.

Effective June 30, 2010.
