1 AMENDMENT NO. 1

2 On page 1, line 4, after "well-being of" delete "livestock" and insert "bovine, equine, ovine,  
3 caprine, porcine,"

4 AMENDMENT NO. 2

5 On page 1, line 6, after "well-being of" delete "livestock" and insert "bovine, equine, ovine,  
6 caprine, porcine,"

7 AMENDMENT NO. 3

8 On page 1, line 14, after "well-being of" delete the remainder of the line and insert the  
9 following:

10 "bovine, equine, ovine, caprine, porcine, and poultry bred, kept, maintained,  
11 raised, or used for show, profit, or for the purpose of selling or otherwise  
12 producing crops, animals, or plant or animal products for market."

13 AMENDMENT NO. 4

14 On page 1, line 16, after "husbandry of the" delete "livestock" and insert "bovine, equine,  
15 ovine, caprine, porcine,"

16 AMENDMENT NO. 5

17 On page 2, line 2, after "standards may have on" delete "livestock" and insert "bovine,  
18 equine, ovine, caprine, porcine,"

19 AMENDMENT NO. 6

20 On page 2, line 3, after "the affected" delete "livestock" and insert "bovine, equine, ovine,  
21 caprine, porcine," and change "sector" to "sectors"

22 AMENDMENT NO. 7

23 On page 2, delete line 10 in its entirety and insert the following:

24 "bovine, equine, ovine, caprine, porcine, and poultry bred, kept, maintained,  
25 raised, or used for show, profit, or for the purpose of selling or otherwise  
26 producing crops, animals, or plant or animal products for market, except as  
27 provided herein."

28 AMENDMENT NO. 8

29 On page 2, at the beginning of line 14, delete "livestock and poultry" and insert the  
30 following:

31 "bovine, equine, ovine, caprine, porcine, and poultry bred, kept, maintained,  
32 raised, or used for show, profit, or for the purpose of selling or otherwise  
33 producing crops, animals, or plant or animal products for market"

1 AMENDMENT NO. 9

2 On page 3, line 3, after "well-being of" delete "livestock and poultry" and insert the  
3 following:

4 "bovine, equine, ovine, caprine, porcine, and poultry bred, kept, maintained,  
5 raised, or used for show, profit, or for the purpose of selling or otherwise  
6 producing crops, animals, or plant or animal products for market"

7 AMENDMENT NO. 10

8 On page 3, line 27, after "well-being of" delete "livestock and poultry" and insert the  
9 following:

10 "bovine, equine, ovine, caprine, porcine, and poultry bred, kept, maintained,  
11 raised, or used for show, profit, or for the purpose of selling or otherwise  
12 producing crops, animals, or plant or animal products for market,"

13 AMENDMENT NO. 11

14 On page 4, between lines 4 and 5, insert the following:

15 "E. Nothing contained in this Section shall prohibit a municipality, parish, local  
16 governmental entity or governing authority of any group or association, private  
17 or public, having jurisdiction over a specific geographic area from enacting  
18 ordinances, laws, subdivision restrictions or regulations regarding possession  
19 of bovine, equine, ovine, caprine, porcine, or poultry."
