
SENATE COMMITTEE AMENDMENTS

Amendments proposed by Senate Committee on Insurance to Original Senate Bill No. 595
by Senator Quinn

1 AMENDMENT NO. 1

2 On page 1, line 11, delete "Chinese"

3 AMENDMENT NO. 2

4 On page 1, delete lines 13 through 17 in their entirety and insert in lieu thereof the following:

5 **"presence of drywall which, prior to December 31, 2009, was imported from, or**
6 **manufactured in, the People's Republic of China."**

7 AMENDMENT NO. 3

8 On page 2, delete lines 1 and 2 in their entirety.

9 AMENDMENT NO. 4

10 On page 2, line 4, after "commissioner" delete the remainder of the line and delete lines 5
11 and 6 in their entirety and insert in lieu thereof the following:

12 **"which penalty shall equal an amount up to one-half the insured value of the**
13 **property, plus all attorney fees, expenses, and court costs incurred by the**
14 **property owner in having the policy reinstated.**

15 **C. Any insurer which has canceled, failed to renew, or increased a policy**
16 **premium or deductible after an insured has made a claim due to the presence**
17 **of Chinese drywall shall have thirty days from the effective date of this Section**
18 **to reinstate the policy on the same terms and conditions that applied to the**
19 **policy prior to the claim or be in violation of the provisions of this Section."**

20 AMENDMENT NO. 5

21 On page 2, delete line 11 in its entirety and insert in lieu thereof the following:

22 **"premium or the policy deductible on any homeowners' insurance policy,**
23 **regardless of whether the policy has been in effect for less than three years,**
24 **based on the presence of"**

25 AMENDMENT NO. 6

26 On page 2, delete lines 13 through 19 in their entirety and insert in lieu thereof the following:

27 **"that is based on the presence of Chinese drywall which, prior to December 31,**
28 **2009, was imported from, or manufactured in, the People's Republic of China."**

29 AMENDMENT NO. 7

30 On page 2, line 21, after "commissioner" delete the remainder of the line in its entirety and
31 delete lines 22 & 23 and insert in lieu thereof the following:

32 **"which penalty shall equal an amount up to one-half the insured value of the**
33 **home, plus all attorney fees, expenses, and court costs incurred by the**
34 **homeowner in having the policy reinstated.**

35 **C. Any insurer which has canceled, failed to renew, or increased a policy**
36 **premium or deductible after an insured has made a claim due to the presence**
37 **of Chinese drywall shall have thirty days from the effective date of this Section**
38 **to reinstate the policy on the same terms and conditions that applied to the**
39 **policy prior to the claim or be in violation of the provisions of this Section."**
