15 **discretion of the property owner or management company regarding a claim**
16 **related to the owner’s property.**

24 On page 5, delete lines 26 through 29 in their entirety and on page 6, delete lines 1 through
25 7 in their entirety and insert in lieu thereof:

26 **“(2) In order to make a determination of eligibility, the commissioner of**
27 **insurance shall require all business entities that are applying to do business as**
28 **independent adjusting companies to provide the names, addresses, social**
29 **security numbers, criminal and administrative history, fingerprints,**
30 **background checks, and biographical statement, of all executive officers and**
31 **directors of the applicant and of all executive officers and directors of entities**
32 **owning and any individuals owning, directly or indirectly, fifty-one percent or**
33 **more of the outstanding voting securities of the applicant. Any nonresident**
34 **business entity applicant whose state of domicile complies with all of the**
35 **provisions of this Paragraph shall not be required to submit a criminal history,**
36 **background check, and biographical statement for its executive officers,**
37 **directors and owners of outstanding voting securities.”**
