Amendments proposed by Senator Hebert to Engrossed Senate Bill No. 662 by Senator Hebert

1 AMENDMENT NO. 1

2 On page 1, line 1, after "1667(A)", insert a comma (,) and delete "and"

3 AMENDMENT NO. 2

4 On page 1, line 2, after "1665(E)," insert "and to repeal R.S. 22:1669(C),"

5 AMENDMENT NO. 3

6 On page 1, line 13, delete "**a person**" and insert "an individual"

7 AMENDMENT NO. 4

8 On page 3, delete lines 6 through 10 in their entirety and in lieu thereof insert the following:
9 "(4) A producer of an authorized insurer or a licensed employee of a producer who processes
10 an undisputed or uncontested loss for the insurer under a policy issued by the producer."

11 AMENDMENT NO. 5

12 On page 3, delete lines 13 through 29 in their entirety and in lieu there of insert the
13 following:

14 **"(6)(A) An individual who collects claim information from, or furnishes claim**
15 **information to, insured or claimants, who conducts data entry including entering data**
16 **into an automated claims adjudication system provided such individual is an employee**
17 **of a business entity licensed pursuant to this Chapter, or an employee of an affiliate of**
18 **a business entity licensed pursuant to the Chapter, if there are no more than twenty-**
19 **five individuals under the supervision of one licensed individual adjuster or licensed**
20 **individual insurance producer. As used in this Part, "automated claims adjudication**
21 **system" means a preprogrammed computer system designed for the collection, data**
22 **entry, calculation and system generated final resolution of consumer electronic**
23 **products insurance claims which:**

24 **(1) May only be utilized by a licensed adjuster or licensed producer, or supervised**
25 **individuals operating pursuant to this Paragraph;**

26 **(2) Must comply with all claims payment requirements of the Louisiana Insurance**
27 **Code; and**

28 **(3) Must be certified as compliant with this Section by a licensed adjuster that is an**
29 **officer of a licensed business entity under this Chapter.**

30 **(6)(B) Individuals who are licensed as producers pursuant to R.S. 22:1543 are not**
31 **required to be licensed as an adjuster for purposes of this Section."**

33 On page 4, delete lines 26 and 27 in their entirety.

35 On page 4, line 28, delete "**(16)**" and insert "**(15)**"

36 AMENDMENT NO. 7

37 On page 5, delete lines 13 through 24 in their entirety and in lieu thereof insert the following

1 **"(2) All business entities applying to do business as independent adjusting companies**
2 **must provide a listing of all executive officers and directors of the applicant and of all**
3 **executive officers and directors of entities owning and any individuals owning, directly**
4 **or indirectly, ten percent or more of the outstanding voting securities of the applicant.**
5 **In order to make a determination of eligibility, the commissioner may require any**
6 **person listed above to submit addresses, social security numbers, criminal and**
7 **administrative history, fingerprints, background checks, and biographical statements."**

9 On page 6, line 27, delete "**a person**" and insert "an individual"

11 On page 7, line 1, delete "**persons**" and insert "individuals"
