

SENATE FLOOR AMENDMENTS

Amendments proposed by Senators Morrell and Murray to Engrossed Senate Bill No. 509 by Senator Long

1 AMENDMENT NO. 1

2 On page 1, line 2, after "To" and before "enact" insert "amend and reenact R.S.  
3 17:1970.27(A) and to"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "Arts" delete the remainder of the line and insert the following:

6 "and the New Orleans Center for the Creative Arts; to provide for the inclusion of  
7 the schools in"

8 AMENDMENT NO. 3

9 On page 1, line 6, after "to the" delete the remainder of the line, delete line 7, and insert the  
10 following:

11 "annual budget of the Louisiana School for Math, Science, and the Arts; and to  
12 provide for related matters."

13 AMENDMENT NO. 4

14 On page 1, line 9, after "Section 1." insert "R.S. 17:1970.27(A) is hereby amended and  
15 reenacted and"

16 AMENDMENT NO. 5

17 On page 2, between lines 21 and 22, insert the following:

19 §1970.27. Funding; acceptance of other funds

20 A. (1) Funds for the operation of the center **New Orleans Center for the**  
21 **Creative Arts** and the programs provided by the center **New Orleans Center for**  
22 **the Creative Arts** shall come from monies appropriated therefor by the legislature  
23 **and through funds appropriated for the minimum foundation program and**  
24 **allocated to the school by the Department of Education.**

25 (2) For the purposes of this Section, the **New Orleans Center for the**  
26 **Creative Arts** shall be considered a public secondary school and, as such, shall  
27 **be included by the State Board of Elementary and Secondary Education in the**  
28 **formula required by Article VIII, Section 13 of the Constitution of Louisiana**  
29 **used to determine the cost of a minimum foundation program of education in**  
30 **all public elementary and secondary schools.**

31 (3) **Minimum foundation program funds allocated to the New Orleans**  
32 **Center for the Creative Arts shall be based upon that portion of the New**  
33 **Orleans Center for the Creative Arts' enrollment which is not included in the**  
34 **enrollment count for the minimum foundation program of any city, parish, or**  
35 **other local public school system and each student shall be funded at one**  
36 **hundred percent of the state base per pupil amount as contained in the**  
37 **minimum foundation program budget letter approved by the State Board of**  
38 **Elementary and Secondary Education.**

39 (4) **The amount of funding for any budget request submitted as provided**  
40 **in this Section that is not provided through the minimum foundation program**  
41 **formula shall be determined by the legislature.**
