**SENATE FLOOR AMENDMENTS**

Amendments proposed by Senator Jackson to Engrossed Senate Bill No. 293 by Senator Donahue

1 AMENDMENT NO. 1

2 On page 1, line 2, after "To enact", delete the remainder of the line and insert "R.S. 39:84.1,  
3 relative to agency position attrition analysis in the"

4 AMENDMENT NO. 2

5 On page 1, line 8, change "42:375.1" to "39:84.1"

6 AMENDMENT NO. 3

7 On page 1, line 9, change "§375.1. Agency" to "§84.1 Agency position"

8 AMENDMENT NO. 4

9 On page 1, delete lines 11 through 16 and insert the following:

10 **"an agency position attrition analysis process to be used by each executive**  
11 **branch agency to review historical position vacancies, relative to authorized**  
12 **positions for each budget unit, program, and subprogram. For comparative**  
13 **purposes, Fiscal Year 2007-2008 shall be established as the base year. Beginning**  
14 **in Fiscal Year 2010-2011 and each year thereafter, each agency shall compare**  
15 **the number of authorized positions for each budget unit, program, and**  
16 **subprogram to the number of authorized positions for those budget units,**  
17 **programs, and subprograms within the agency during the base year. The**  
18 **agency shall note all changes across budget units, programs, and subprograms,**  
19 **as well as any changes that occur relative to the distribution of positions within**  
20 **salary ranges."**

21 AMENDMENT NO. 5

22 On page 2, between lines 6 and 7, insert the following:

23 **"(4) Any workload measures which affect changes in the number of**  
24 **positions over time.**

25 **(5) Any changes in law which affect staffing needs of an agency."**

26 AMENDMENT NO. 6

27 On page 2, delete lines 7 through 13 and insert the following:

28 **"C. Each executive branch agency shall report the results of its analysis**  
29 **as provided by Subsection A of this Section to the commissioner of**  
30 **administration no later than January 15 of each year. On the first day of the**  
31 **month following the month in which the executive budget is submitted to the**  
32 **Joint Legislative Committee on the Budget, the commissioner of administration**  
33 **shall provide a written report to the Commission on Streamlining Government."**

34 AMENDMENT NO. 7

35 On page 2, line 21, after "**authorized**" delete the remainder of the line and at the beginning  
36 of line 22 delete "**time**"

1 AMENDMENT NO. 8

2 On page 2, after line 24, insert the following:

3 **"E. Nothing in this Section shall limit the authority of the management**  
4 **boards of public postsecondary education to manage the institutions under their**  
5 **authority, pursuant to the Louisiana Constitution or as otherwise provided in**  
6 **R.S. 17:3351 et seq."**
