4 On page 2, at the beginning of line 9, change "**such**" to "**the**"

5 AMENDMENT NO. 3

6 On page 2, line 14, after "**disaster**" delete the remainder of the line and from the beginning
7 of line 15, delete "**insurers.**" and insert a comma "," and insert the following: "**or if a**
8 **homeowner has a damage claim filed and pending against the insurer of the property.**"

9 AMENDMENT NO. 4

10 On page 2, line 17, after "**process or**" delete the remainder of the line and delete lines 18 and
11 19 in their entirety and insert the following:

12 **"official documentation evidencing the homeowner has a damage claim filed and**
13 **pending against the insurer of the property."**

14 AMENDMENT NO. 5

15 On page 2, at the beginning of line 20, change "**(ii)**" to "**(c)**" and change "**Item (i)**" to
16 "**Subparagraph (b)**"

17 AMENDMENT NO. 6

18 On page 2, at the beginning of line 21, change "**Subparagraph**" to "**Paragraph**"

19 AMENDMENT NO. 7

20 On page 2, line 23, after "**shall**" and before "**be**" insert "**only**"

21 AMENDMENT NO. 8

22 On page 3, at the beginning of line 19, change "**(b)(i)**" to "**(b)**"

23 AMENDMENT NO. 9

24 On page 3, line 24, after "**is**" and before "**filed**" delete "**either**"

25 AMENDMENT NO. 10

26 On page 3, line 27, after "**disaster**" delete the remainder of the line and from the beginning
27 of line 28, delete "**against the homeowner's insurer or insurers.**" and insert a comma ","

1 and insert "**or if a homeowner has a damage claim filed and pending against the insurer**
2 **of the property.**"

4 On page 3, line 29, after "**level**" and before "**with**" delete "**directly**"

5 AMENDMENT NO. 12

6 On page 4, line 4, after "**documentation**" delete the remainder of the line and delete line 5
7 in its entirety and insert the following:

8 **"evidencing the homeowner has a damage claim filed and pending against the**
9 **insurer of the property.**"

10 AMENDMENT NO. 13

11 On page 4, at the beginning of line 6, change "**(ii)**" to "**(c)**" and change "**Item (i)**" to
12 "**Subparagraph (b)**"

13 AMENDMENT NO. 14

14 On page 4, at the beginning of line 7, change "**Subparagraph**" to "**Paragraph**"
