16 "N. No concealed handgun may be carried into and no concealed handgun
17 permit issued pursuant to this Section shall authorize or entitle a permittee to carry
18 a concealed handgun in any of the following:

20 (8) Any church, synagogue, mosque, or other similar place of worship,
21 eligible for qualification as a tax-exempt organization under 26 U.S.C. 501, except
22 as provided for in Subsection U of this Section.

23 * * *

24 U.(1) The entity which owns the business or has authority over the
25 administration of a church, synagogue, or mosque shall have the authority to
26 authorize any person issued a valid concealed handgun permit as authorized by the
27 provisions of this Section to carry a concealed handgun in the church, synagogue, or
28 mosque.29 (2) The provisions of this Subsection shall not be construed to limit or
30 prohibit any church, synagogue, or mosque from employing armed security guards
31 who are either certified law enforcement officers or who are authorized to carry
32 concealed handguns pursuant to the provisions of this Section.33 (3) If the church, synagogue, or mosque authorizes the carrying of concealed
34 handguns as authorized by the provisions of this Subsection, the pastor, priest,
35 minister, or other authority of the church, synagogue, or mosque shall inform the
36 congregation of the authorization.37 (4) The provisions of this Section shall not be construed to authorize the
38 carrying of a concealed handgun in a church, synagogue, or mosque located on the
39 property of any school or school property, which would otherwise be prohibited by
40 the provisions of R.S. 14:95.2.

1 (5) Any church, synagogue, or mosque authorizing the carrying of concealed
2 handguns pursuant to the provisions of this Subsection shall require an additional
3 eight hour tactical training for those persons wishing to carry concealed handguns
4 in the church, synagogue, or mosque. The training shall be conducted annually."
