The proposed legislation provides relative to: restructuring the offices within the Department of Education and their functions; provides relative to the titles of officers of the department; provides relative to the appointment and duties of the deputy superintendent of education; provides relative to the purposes and functions of certain offices; removes duplicative or outdated provisions; provides for the appointment, qualifications, salaries and requirement of Senate confirmation of the administrative heads of the Recovery School District and the Special School District; and, deletes provisions relative to the establishment and operations of regional education service centers.

The expenditures, savings and personnel reductions associated with the reorganization were realized and accounted for in the current fiscal year. This proposed legislation codifies in state statute the current organizational structure of the department.
