

SENATE COMMITTEE AMENDMENTS

Amendments proposed by Senate Committee on Health and Welfare to Reengrossed House Bill No. 636 by Representative Hoffmann

1 AMENDMENT NO. 1

2 On page 1, line 2 after "reenact" and before "1299.35.9(A)(1)" delete "R.S. 40:1299.35.6"
3 and insert "R.S. 40:1299.35.1(1)(b), 1299.35.6"

4 AMENDMENT NO. 2

5 On page 1, line 11 after "R.S." and before "1299.35.9(A)(1)" delete "40:1299.35.6" and
6 insert "40:1299.35.1(1)(b), 1299.35.6"

7 AMENDMENT NO. 3

8 On page 2, between lines 3 and 4 insert the following:

9 " (1) "Abortion" or "induced abortion" means the act of using or prescribing
10 any instrument, medicine, drug, or any other substance, device, or means with the
11 intent to terminate the clinically diagnosable pregnancy of a woman with knowledge
12 that the termination by those means will, with reasonable likelihood, cause the death
13 of the unborn child. Such use, prescription, or means is not an abortion if done with
14 the intent to:

15 * * *

16 (b) Remove ~~a dead unborn child caused by the uterine contents in case of a~~
17 positive diagnosis of spontaneous abortion, missed abortion, or inevitable abortion,
18 incomplete abortion, or septic abortion."

19 AMENDMENT NO. 4

20 On page 2, delete line 10 and insert "B. Any licensed Outpatient Abortion Facility as defined
21 by R.S. 40:2175.3 shall"

22 AMENDMENT NO. 5

23 On page 2, delete lines 17 and 18 in their entirety and insert the following:

24 " * It is unlawful for anyone to make you have an abortion against your will, even if
25 you are a minor.

26 AMENDMENT NO. 6

27 On page 2, line 20 after "child" and before "support" delete "is liable to assist in the" and
28 insert "must provide"

29 AMENDMENT NO. 7

30 On page 2, line 23 after "law" and before "adoptive" delete "permits" and insert "allows"

31 AMENDMENT NO. 8

32 On page 2, line 26 after "Many" and before "agencies" delete "public and private"

33 AMENDMENT NO. 9

34 On page 3, between lines 12 and 13 insert the following:

3 On page 14, line 12 after "function." delete the remainder of the line

4 AMENDMENT NO. 11

5 On page 14, delete lines 13 through 18 in their entirety

6 AMENDMENT NO. 12

7 On page 17, delete lines 6 through 8 in their entirety and insert the following:

8 " Whoever violates the provisions of this Part shall be fined not less than two
9 thousand five hundred dollars and not more than ~~one~~ twenty thousand dollars, or
10 imprisoned for not more than two years, or both."
