**HOUSE FLOOR AMENDMENTS**

Amendments proposed by Representative Tucker to Re-Reengrossed Senate Bill No. 266 by Senator Appel

1 AMENDMENT NO. 1

2 On page 1, line 2, change "17:3230" to "17:3230 and Part III-A of Chapter 26 of Title 17 of  
3 the Louisiana Revised Statutes of 1950, to be comprised of R.S. 17:3241"

4 AMENDMENT NO. 2

5 On page 1, line 12, change "17:3230 is" to "17:3230 and Part III-A of Chapter 26 of Title  
6 17 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 17:3241, are"

7 AMENDMENT NO. 3

8 On page 3, line 15, after "**System.**" delete the remainder of the line and delete lines 16-20  
9 in their entirety.

10 AMENDMENT NO. 4

11 Delete Amendment Nos. 5 and 6 proposed by the House Committee on Education and  
12 adopted by the House on June 19, 2011.

13 AMENDMENT NO. 5

14 On page 5, line 6, after "**System.**" delete the remainder of the line and delete lines 7 though  
15 19 in their entirety and insert the following:

16 "Such funding and resources shall not impact the Board of Regents' formula for the  
17 equitable distribution of funds to institutions of postsecondary education."

18 **G.(1) The University of New Orleans, pursuant to their agreement with**  
19 **the University of New Orleans Foundation, shall reimburse the state for the**  
20 **purchase of available insurance for indemnification and costs which may arise**  
21 **from the transfer; provided however, that the state of Louisiana shall indemnify**  
22 **and hold harmless the Board of Supervisors of Louisiana State University and**  
23 **Agricultural and Mechanical College and the Board of Supervisors for the**  
24 **University of Louisiana System for any liability and costs which may result**  
25 **from the transfer of existing contracts, financing, or immovable property.**

26 **(2) Effective beginning with the 2011-2012 Fiscal Year, any and all funds**  
27 **previously paid by the University of New Orleans to the Board of Supervisors**  
28 **of Louisiana State University and Agricultural and Mechanical College shall be**  
29 **paid instead to the Board of Supervisors for the University of Louisiana System;**  
30 **however, the total amount of such payments shall not be less than that paid**  
31 **during the 2010-2011 Fiscal Year."**

33 On page 5, at the beginning of line 20, change "**G.**" to "**H.**"

4 **PART III-A. POSTSECONDARY EDUCATION DELIVERY SYSTEM FOR**  
5 **THE NEW ORLEANS REGION**

6 **§3241. Legislative intent; goals**

7 **A. It is the intent of the legislature that a comprehensive, integrated**  
8 **regional delivery system be provided for the delivery of public postsecondary**  
9 **education services in the New Orleans region which system will:**

10 **(1) Provide a world class educational environment that will meet the**  
11 **academic needs and interests of every student, while providing each student**  
12 **with the support, assistance, and guidance necessary to attain his or her**  
13 **educational goals and aspirations.**

14 **(2) Ensure that students who are academically unprepared are provided**  
15 **the educational resources they need to have a reasonable chance for success in**  
16 **their academic pursuits.**

17 **(3) Raise the educational attainment of the population, improve the**  
18 **quality of life, and contribute to the economic well being of the New Orleans**  
19 **region.**

20 **(4) Make optimal use of facilities, faculties, and other academic and**  
21 **fiscal resources associated with the public postsecondary institutions in the**  
22 **region.**

23 **B. The legislature finds that these goals will best be accomplished**  
24 **through the following actions:**

25 **(1) The Board of Regents shall adopt by not later than February 1, 2012,**  
26 **a written plan of action including timelines, deadlines, requirements, and**  
27 **procedures for achieving the goals specified in Subsection A of this Section as**  
28 **such goals relate to the powers, duties, functions, and responsibilities of the**  
29 **board provided by Article VIII, Section 5, of the Constitution of Louisiana and**  
30 **other applicable law. The board shall submit copies of the adopted action plan**  
31 **to the House Committee on Education and the Senate Committee on Education.**

32 **(2) The Board of Supervisors of Southern University and Agricultural**  
33 **and Mechanical College, the Board of Supervisors for the University of**  
34 **Louisiana System, and the Board of Supervisors of Community and Technical**  
35 **Colleges each shall adopt by not later than February 1, 2012, a written plan of**  
36 **action including timelines, deadlines, requirements, and procedures for**  
37 **achieving the goals specified in Subsection A of this Section as they relate to the**  
38 **powers, duties, functions, and responsibilities of the boards provided by Article**  
39 **VIII, Section 5(E), of the Constitution of Louisiana and other applicable law.**  
40 **Each board also shall submit copies of its adopted action plan to the House**  
41 **Committee on Education and the Senate Committee on Education."**
