HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Lopinto to Engrossed House Bill No. 45 by Representative Lopinto

1 AMENDMENT NO. 1

2 On page 3, between lines 15 and 16, insert the following:

3 "(4) "Louisiana firearms manufacturer" means any person who has been
4 issued a manufacturer's license as provided for in this Part and is engaged in this
5 state in the business of manufacturing any Louisiana manufactured firearm, firearm
6 accessories, or ammunition."

7 AMENDMENT NO. 2

8 On page 3, line 22, after "which" and before "manufactured" delete "is" and insert "are"

9 AMENDMENT NO. 3

10 On page 7, at the end of line 2, change "R.S. 40:1827." to "R.S. 40:1826."

11 AMENDMENT NO. 4

12 On page 7, between lines 2 and 3, insert the following:

13 "E. The department shall not be required to issue a license to sell Louisiana
14 firearms, firearm accessories, or ammunition pursuant to the provisions of this
15 Section until it has issued a manufacturing license pursuant to the provisions of R.S.
16 40:1825 and has adopted rules pursuant to the provisions of R.S. 40:1826 to
17 implement the provisions of this Section."

18 AMENDMENT NO. 5

19 On page 8, between lines 8 and 9, insert the following:

20 "F. The provisions of this Section shall not be construed or interpreted to
21 require that any federally licensed manufacturer of firearms which is domiciled in
22 the state of Louisiana obtain a license to manufacture firearms as provided for in this
23 Section unless it chooses to avail itself of the provisions of this Part."

24 AMENDMENT NO. 6

25 On page 8, between lines 11 and 12, insert the following:

26 "C. Any rules adopted pursuant to the provisions of this Section shall be
27 subject to legislative oversight by the House Committee on the Administration of
28 Criminal Justice and the Senate Committee on Judiciary C."

1 AMENDMENT NO. 7

2 On page 9, line 25, change "B." to "B.(1)"

3 AMENDMENT NO. 8

4 On page 9, line 28, after "jurisdictions." delete the remainder of the line

5 AMENDMENT NO. 9

6 On page 9, delete line 29 in its entirety

7 AMENDMENT NO. 10

8 On page 10, delete lines 1 through 11 in their entirety and insert the following:

9 "(2) The department shall review the criminal history of the purchaser and
10 provide a response of "approved" or "denied" of the transaction to the dealer. No
11 dealer shall proceed with the transaction unless the transaction is approved by the
12 department."

13 AMENDMENT NO. 11

14 On page 10, at the beginning of line 12, delete "(2)" and insert "C."
