Constitutional amendment to grant the Southeast Baton Rouge community school system in East Baton Rouge Parish the same authority granted parishes relative to MFP funding and raising revenue for schools. (2/3 - CA13s1(A))

The proposed constitutional amendment grants the Southeast Baton Rouge Community School System in East Baton Rouge Parish the same authority granted parishes for purposes of Article VIII, Section 13 of the Constitution of Louisiana, including purposes related to the minimum foundation program, funding for certain school books and instructional materials, and the raising of certain local revenues for the support of elementary and secondary schools. The proposed amendment shall be submitted to the electors of the State of Louisiana at the statewide election to be held on November 4, 2014.
