AN ACT

To amend and reenact R.S. 13:2575(A), (B), (C)(2), (D), (F) and (H) and 2576(A)(introductory paragraph) and to enact R.S. 13:2576(A)(7), relative to administrative adjudication procedures for blighted or abandoned property, public health, housing, fire code, environmental and other ordinance violations; to provide certain municipal and parish population requirements and restrictions; to provide certain terms, conditions, requirements, and procedures; to provide for the enforcement of ordinances through administrative adjudication procedures and other procedures, including liens, actions and tax sales; to provide for the effects of such procedures and judgments; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 13:2575(A), (B), (C)(2), (D), (F) and (H) and 2576(A)(introductory paragraph) are hereby amended and reenacted and R.S. 13:2576(A)(7) is hereby enacted to read as follows:

§2575. ~~Municipalities with populations in excess of three hundred thousand;~~  
**Blighted or abandoned property;** public health, housing, **fire code,**  
**building code and certain other ordinance** ~~and environmental~~  
violations; administrative adjudication; procedure; appeal; penalties

A.**(1)** Any municipality or parish may prescribe civil fines for **blighted**

1 **property, abandoned property, or** violation of public health, housing, fire code,  
2 environmental, and historic district ordinances in the municipality or parish by  
3 owners of immovable property, their agents, tenants, or representatives pursuant to  
4 the procedures for administrative adjudication provided in this Chapter. For the  
5 purposes of this Chapter, "housing violations" shall encompass only those conditions  
6 in privately owned structures which are determined to constitute a threat or danger  
7 to the public health, safety or welfare ~~and/or,~~ to the environment, or a historic  
8 district. In municipalities with a population of seventy thousand or more **according**  
9 **to the latest federal decennial census,** the term "housing violation" as used in this  
10 Chapter shall also encompass building codes, zoning, vegetation, and nuisance  
11 ordinances. However, nothing in this Section shall be construed to affect activities  
12 which occur on the premises of manufacturing facilities and which are regulated by  
13 Title 30 of the Louisiana Revised Statutes of 1950.

14 **(2) For purposes of this Chapter, except in any parish with a population**  
15 **of more than three hundred thousand and less than four hundred thousand**  
16 **according to the latest federal decennial census, "blighted property" shall have**  
17 **the same meaning as provided in R.S. 33:1374(B)(1), and "abandoned**  
18 **property" shall have the same meaning as provided in R.S. 33:4720.59(D)(2).**

19 B.(1) Any municipality or parish may adopt an ordinance or ordinances  
20 establishing an administrative adjudication hearing procedure under the provisions  
21 of this Chapter. The ordinance or ordinances shall provide for a time period for  
22 persons charged with **owning blighted or abandoned property, or** violating a  
23 public health, housing, fire code, environmental, and historic district ordinance to  
24 have a hearing under the provisions of this Chapter. The ordinance shall provide for  
25 the appointment of one or more hearing officers who may be the director of health  
26 of the municipality or parish or the health officer of the parish in which the  
27 municipality is located or the designee of such official or, in the discretion of the  
28 governing authority, who may be a person who shall have been licensed to practice  
29 law in Louisiana for two years.

30 **(2) Except in any parish with a population of more than three hundred**



1           become payable ninety days after the death of the owner thereof or immediately  
2           upon recordation of any conventional mortgage on the immovable property or  
3           transfer of title to a new owner, whichever occurs first.

4           D.(1) Prior to holding an administrative hearing for public health, housing,  
5           fire code, environmental, and historic district violations, the municipality or parish  
6           shall notify the property owner at least fifteen days in advance of the date that such  
7           a hearing is scheduled. This notification shall state the time, date, and location of the  
8           hearing, the alleged violations, and it shall be sent by certified or registered United  
9           States mail to the violator or personally served on the violator at the address as listed  
10          in the assessor's office of the municipality or parish. The date of the postmark shall  
11          be deemed to be the date of delivery. Any notification so sent and returned by the  
12          United States Post Office shall be considered as having fulfilled the notification  
13          requirement. Failure of any person charged with a violation to appear at the hearing  
14          shall be considered an admission of liability for the charged violation. Any order  
15          compelling the attendance of witnesses or the production of documents may be  
16          enforced by the city or municipal court of the municipality or the parish court in  
17          whose jurisdiction the municipality is located, or in the parish court of the parish  
18          initiating the action.

19          (2) Except in any parish with a population of more than three hundred  
20          thousand and less than four hundred thousand according to the latest federal  
21          decennial census, prior to holding an administrative hearing for the  
22          determination of blight or abandonment of property, the municipality or parish  
23          shall notify the property owner and each mortgagee of record in the parish  
24          mortgage records, at least thirty days in advance of the date of the  
25          administrative hearing. The notification shall state the time, date, and location  
26          of the hearing, the location of the subject property, and an explanation that the  
27          hearing is for the purpose of making a determination whether the subject  
28          property is blighted or abandoned. The notice shall be sent by certified or  
29          registered United States mail or personally served on the property owner at the  
30          address listed in the assessor's office of the municipality or parish, and on each

1 mortgagee of record at the address provided in the recorded mortgage.

3 F.(1) The hearing officer shall issue an order within thirty days, excluding  
 4 legal holidays, of the hearing stating whether or not the person charged is liable for  
 5 the violation, and the amount of any fine, penalty, costs, or fee assessed against him,  
 6 and a date by which the violation shall be corrected. In addition to the enforcement  
 7 procedure and authority set forth in Paragraph (B)(2) of this Section, any order  
 8 assessing a fine, penalty, costs, or fee or stipulating a correction date may be  
 9 enforced by the city or municipal court of the municipality or the parish court in  
 10 whose jurisdiction the municipality is located, or in the parish court of the parish  
 11 initiating the action.

12 (2) Except in any parish with a population of more than three hundred  
 13 thousand and less than four hundred thousand according to the latest federal  
 14 decennial census, within thirty days, excluding legal holidays, after the hearing  
 15 to determine whether a property is blighted or abandoned, the hearing officer  
 16 shall send written post hearing notice to the property owner and each  
 17 mortgagee of record explaining whether the hearing officer determined the  
 18 subject property to be blighted or abandoned and state whether any fine,  
 19 penalty, costs, or fees are assessed. The post hearing notice shall be sent to the  
 20 property owner and mortgagees of record in the manner provided for in  
 21 Paragraph (D)(2) of this Section.

23 H. Any property owner or mortgagee of record of property determined  
 24 to be blighted or abandoned property, or any person determined by the hearing  
 25 officer to be in violation of a public health, housing, fire code, environmental, or  
 26 historic district ordinance may appeal this determination to the appropriate district  
 27 court. Such appeal shall be instituted by filing, within thirty calendar days of the  
 28 hearing officer's order, a petition with the clerk of court for the district court along  
 29 with payment of such reasonable costs as may be required by the clerk. After filing  
 30 a petition for appeal, the clerk of court of the district court shall schedule a hearing

1 and notify all parties of the date, time, and place of such hearing. Service of notice  
2 of appeal under this Subsection shall not stay the enforcement and collection of the  
3 judgment unless the person who files the appeal furnishes security prior to filing  
4 notice of appeal with the agency of the municipality or parish designated by  
5 ordinance to accept such payments in the amount to be fixed by the hearing officer  
6 sufficient to assure satisfaction of the finding of the hearing officer relative to the  
7 fine, fee, penalty, costs of the hearing, and costs, if any, of correcting the violation.

9 §2576. Administrative adjudication of **blighted or abandoned property**, public  
10 health, housing, fire code, environmental, and historic district  
11 violations; ~~municipalities with a population in excess of three~~  
12 ~~hundred thousand~~

13 A. In each **any** municipality ~~having a population of three hundred thousand~~  
14 ~~or more according to the latest federal decennial census~~ **or parish**, the failure to pay  
15 the liens, privileges, ~~and~~ judicial mortgages, and any fines, fees, penalties, or hearing  
16 costs imposed pursuant to R.S. 13:2575 shall cause the liens, privileges, ~~and~~ judicial  
17 mortgages, and any fines, fees, penalties, or hearing costs to be enforceable pursuant  
18 to the following provisions, in addition to those provided for in R.S. 13:2575:

20 **(7) If property for which tax sale title was acquired and held by a**  
21 **political subdivision pursuant to R.S. 47:2196 is sold pursuant to this Chapter,**  
22 **upon recordation of such sale the property shall no longer be deemed**  
23 **adjudicated property. For purposes of any rights of redemption required**  
24 **pursuant to state law, the redemption period shall be deemed to have**  
25 **commenced on the date of the recordation of the initial adjudication to the**  
26 **political subdivision and not on the date of sale pursuant to this Chapter.**

28 Section 2. This Act shall become effective upon signature by the governor or, if not  
29 signed by the governor, upon expiration of the time for bills to become law without signature  
30 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

1 vetoed by the governor and subsequently approved by the legislature, this Act shall become  
2 effective on the day following such approval.
