HOUSE BILL NO. 1079

1 AN ACT

2 To amend and reenact R.S. 18:1491.7(B)(13) and 1495.5(B)(12), relative to expenditures of  
3 campaign funds; to require an explanation of the purpose of each expenditure; and  
4 to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 18:1491.7(B)(13) and 1495.5(B)(12) are hereby amended and  
7 reenacted to read as follows:

8 §1491.7. Reports; contents

10 B. Each report required to be in conformity with this Section shall contain  
11 the following information:

13 (13) The full name and address of each person to whom an expenditure has  
14 been made by the committee during the reporting period. The amount, a description  
15 of the purpose as it relates to the expenditure, ~~and the~~ date of each such expenditure,  
16 and the name and address of and office sought by candidates on whose behalf each  
17 such expenditure was made shall be reported. A brief description of an in-kind  
18 expenditure shall be given, as well as the valuation made by the chairman and the  
19 campaign treasurer and the date(s) of the expenditure. When multiple expenditures  
20 have been made to the same person during the reporting period, the aggregate  
21 amount of such expenditures, other than in-kind expenditures, and the aggregate  
22 valuation of in-kind expenditures shall be reported for each such person. The  
23 aggregate of all expenditures made during the reporting period, other than in-kind

1 expenditures, and the aggregate valuation of all in-kind expenditures shall also be  
2 reported. The aggregate amount expended for each candidate shall also be reported.

6 B. Each report required to be in conformity with this Section shall contain  
7 the following information:

9 (12) The full name and address of each person to whom an expenditure has  
10 been made by the candidate during the reporting period. The amount, a description  
11 of the purpose as it relates to the expenditure, and the date of each ~~such~~ expenditure  
12 shall be reported. A brief description of an in-kind expenditure shall be given, as  
13 well as the valuation made by the candidate and the campaign treasurer and the  
14 date(s) of the expenditure. When multiple expenditures have been made to the same  
15 person, during the reporting period, the aggregate amount of such expenditures, other  
16 than in-kind expenditures, and the aggregate valuation of in-kind expenditures shall  
17 be reported for each such person. The aggregate of all expenditures made during the  
18 reporting period, other than in-kind expenditures, and the aggregate valuation of all  
19 in-kind expenditures shall also be reported. The aggregate amount expended for  
20 each candidate shall also be reported.
