CONTROLLED SUBSTANCES: Adds substances to Schedules II and IV of the Uniform Controlled Dangerous Substances Law

1 AN ACT

2 To amend and reenact R.S. 40:964 (Schedule II)(A)(1) and (4) and to enact R.S.
3 40:964(Schedule IV)(E)(3), relative to the Uniform Controlled Dangerous
4 Substances Law; to add certain substances to Schedules II and IV; and to provide for
5 related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 40:964 (Schedule II)(A)(1) and (4) are hereby amended and reenacted
8 and R.S. 40:964(Schedule IV)(E)(3) is hereby enacted to read as follows:

9 §964. Composition of schedules

10 Schedules I, II, III, IV, and V shall, unless and until added to pursuant to R.S.
11 40:962, consist of the following drugs or other substances, by whatever official
12 name, common or usual name, chemical name, or brand name designated:

14 SCHEDULE II

15 A. Substances of vegetable origin or chemical synthesis. Unless specifically
16 excepted or unless listed in another schedule, any of the following substances
17 whether produced directly or indirectly by extraction from substances of vegetable
18 origin, or independently by means of chemical synthesis, or by a combination of
19 extraction and chemical synthesis:

1 (1) Opium and opiate, and any salt, compound, isomer, derivative, or
2 preparation of opium or opiate, excluding apomorphine, thebaine-derived
3 butorphanol, dextrorphan, nalbuphine, nalmefene, naloxegol, naloxone, and
4 naltrexone, and their respective salts, but including the following:

6 (4) Coca leaves, and any salt, compound, derivative, or preparation of coca
7 leaves (including cocaine; ecgonine and their salts, isomers, derivatives and salts of
8 isomers and derivatives), ~~and any salt, isomer, salt of an isomer, compound,~~
9 ~~derivative, or preparation of coca leaves, cocaine or ecgonine~~ and any salt, isomer,
10 ~~salt of an isomer,~~ compound, derivative, or preparation thereof which is chemically
11 equivalent or identical with any of these substances, except that the substances shall
12 not include:

13 (i) ~~decocainized~~ Decocainized coca leaves or extraction of coca leaves, which
14 extractions do not contain cocaine or ecgonine,

15 (ii) [¹²³I]ioflupane.

Abstract: Amends the Uniform Controlled Dangerous Substances Law in La. to provide for consistency with federal law regarding controlled dangerous substances.

Present law provides for the designation of controlled dangerous substances into Schedules I, II, III, IV, and V based upon the substances' potential for addiction and abuse.

Proposed law amends provisions of present law regarding Schedule II and Schedule IV substances to bring La. law into compliance with federal law regarding controlled dangerous substances.

(Amends R.S. 40:964(Schedule II)(A)(1) and (4); Adds R.S. 40:964(Schedule IV)(E)(3))
