9	Section 1. R.S. 36:509(S) is hereby repealed.
10	Section 2. Part XXVI of Chapter 13 of Title 38 of the Louisiana Revised Statutes of
11	1950, comprised of R.S. 38:3087.191 through 3087.205, is hereby repealed in its entirety.

<u>Present law</u> establishes the Washington Parish Reservoir District. Provides that the district shall be a political subdivision of the state and shall be comprised of the area of Washington Parish.

Page 1 of 2 Coding: Words which are struck through are deletions from existing law; words in **boldface type and underscored** are additions. <u>Present law</u> provides that the district's purpose is to develop the wealth and natural resources of the district by conserving soil and water for agricultural, recreational, commercial, industrial, and sanitary purposes. Provides that the district shall create and maintain lakes and reservoirs and engage in economic development.

<u>Present law</u> provides that the district shall constitute a body corporate and shall have the authority to sue and be sued, buy and sell, levy taxes, negotiate and execute contracts, and incur debt and issue negotiable bonds.

<u>Present law</u> provides that the district shall be exempt from taxation. Authorizes the district to cooperate and contract with the federal or state government or any department or agency for the construction, operation, and maintenance of facilities.

<u>Present law</u> provides that the district is governed by a board of 11 commissioners, appointed by the governor subject to Senate confirmation, who shall be qualified electors of the state residing within Washington Parish.

<u>Present law</u> prohibits any person or corporation from erecting any dam or reservoir upon any watercourse which will affect the district without the approval of the board of commissioners. Provides for penalties of not less than \$500 nor more than \$1,000 or imprisonment for not more than 60 days, or both.

Proposed law repeals present law.

Effective August 1, 2016.
