SPECIAL DISTRICTS Provides relative to per diem for the Rapides Parish Sewerage District No. 2. (8/1/17)

Purpose of Bill: This measure allows the governing authority of Rapides Parish to increase the per diem for members of the board of supervisors of Sewerage District No. 2 from \$90 to \$150 per meeting.

EXPENDITURE EXPLANATION

This bill may increase local fund expenditures by \$6,480 annually for Sewerage District No. 2 of Rapides Parish.

The proposed bill provides for an increase in per diem paid to each board member from \$90 to \$150 for each board meeting attended. This measure provides for a maximum of 12 emergency and 24 regular meetings per year for a maximum of 36 meetings. Currently the district consists of 3 members who each receive \$90 for attending a maximum of 36 meetings.

If the board meets for the statutorily maximum allowable number of meetings, the current per diem would be \$9,720 annually (\$90 per diem x 36 meetings x 3 board members). If the board meets the maximum number of times with the increased per diem provided in this measure (\$150), expenditures would total \$16,200 annually (\$150 per diem x 36 meetings x 3 board members). Therefore the proposed legislation may increase local fund expenditures by \$6,480 annually (\$16,200 - \$9,720).

REVENUE EXPLANATION

There is no anticipated direct material effect on governmental revenues as a result of this measure.
